5	Outcome of Children's Services Ofsted Inspection and Ofsted Action Plan
	Councillor Val Gibson presented the report and action plan and informed the meeting that the outcome was very positive for the Council. The Ofsted rating received placed
	Wolverhampton as second in the West Midlands and first in the West Midlands

Combined Authority area based on the new criteria. Key findings from the inspection included effective and strong corporate leadership, a clear sense of vision and purpose and that good and sustained improvements had been made across the service. The action plan centred around the eleven recommendations made by Ofsted and outlined the proposed action against each recommendation. Good progress was already being made. Delivery Boards would be established to monitor progress going forward and the Children's Trust Board would have overall responsibility.

Resolved:

- 1. That the 'Good' overall judgement from the recent Ofsted Inspection of services for children in need of help and protection be celebrated and the Council's excellent position in the West Midlands and the country be noted.
- 2. That the Ofsted Action Plan which had been produced in response to recommendations from the inspection be approved.

6 **Outcome of the Local Government Association Corporate Peer Review**

Councillor Roger Lawrence presented the outcome of the Local Government Association (LGA) Corporate Peer Review and the action plan that had been created to address the recommendations following the visit. The Peer Team concluded that the City of Wolverhampton Council had been on 'an impressive journey of improvement' and was 'in a strong position to respond with confidence to both current and future challenges facing the City'. The Action Plan detailed how each recommendation would be addressed going forward with timescales attached to aid in monitoring progress.

- 1. That the draft action plan arising from the recommendations within the Local Government Association (LGA) Corporate Peer Review final report be approved.
- That it be approved that the LGA conduct a follow up visit in February 2018 to assess the progress that the City of Wolverhampton Council had made with regards to the recommendations set out in the final report.
- 1. That the outcome and issues raised in the LGA Corporate Peer Review final report be noted.
- 2. That it be noted that this report would also be considered by Scrutiny Board on 25 April 2017.
- 7 Better Care Fund Section 75 Agreement (Pooled Budget 2017-18) & Additional Adult Social Care monies announced during the Spring 2017 Budget statement Councillor Sandra Samuels sought approval to renew the Section 75 Agreement (Pooled Fund) with NHS Wolverhampton Clinical Commissioning Group for 2017-18 and delegate authority to approve the final terms of the proposed Section 75 Agreement. The report outlined the proposed use of the additional non-recurring monies that had been announced in the Spring 2017 budget statement. The monies would be focussed on areas including Behaviour Change/Demand Management programme implementation and the Reconfiguration of Older People's service activity. An amendment to recommendation 3 of the report was requested to include the Chair of the Health and Wellbeing Board as an additional recipient of the delegated authority.

Resolved:

- 1. That the report proposing the use of the additional non-recurring monies announced during the Spring 2017 budget statement be noted and received.
- 2. That it be agreed to renew the Section 75 Agreement (Pooled Fund) with NHS Wolverhampton Clinical Commissioning Group ("WCCG") for 2017-18.
- 3. That authority be delegated to the Chair of the Health and Wellbeing Board and the Cabinet members for Adults, Public Health and Well Being and Resources, (Cllrs. Roger Lawrence, Paul Sweet, Sandra Samuels OBE and Andrew Johnson), in consultation with Strategic Director for People and Director of Finance, to approve the final terms of the proposed Section 75 Agreement.

8 **Connected Places Strategy Summary Document**

Councillor John Reynolds presented the Connected Places Strategy Summary document for approval for distribution. The document bought together the Car Parking and Connected Places Strategies and emphasised the importance of connectivity between key destinations. Whilst the strategy aimed to improve existing channels of transport, non-car based models of transport were also promoted. The images in the document were contextual and the effect of the strategy on buses and taxis were also being examined in the process.

Resolved:

- 1. That the Connected Places Strategy summary document be approved for distribution.
- 1. That the progress of a number of Connected Places projects and work streams that have emerged as a consequence of the strategy's development be noted.

9 Transportation Capital Programme - 2017/18 and future years

Councillor Steve Evans presented the Transportation Capital Programme for 2017/18 and future years, which outlined the projects planned for development and implementation during that period. The Council had experienced success in bidding for additional grants for highways and transport projects. Existing road networks were already being improved and work on this would continue, projects were also planned for rail, cycle and footpath routes as well. It was noted that the Council was listening to residents and amending schemes following public consultations.

- 1. That the list of projects for development and implementation as part of the Transportation Capital Programme 2017/18 and future years, as set out in appendices B and C to the report, be agreed.
- 2. That the Head of Strategic Transportation and the Head of Highways Network be authorised to proceed with development work for each project on the list including surveying, site investigation, options appraisal, feasibility analysis, traffic modelling, detailed design, statutory advertising and public consultation, as appropriate.
- 3. That the projects marked 'Approve' in the 'Approval' column of appendix B to the report for implementation be approved, subject to the availability of funding.

- 4. That the Cabinet Member for City Environment be authorised, in consultation with the Service Director, City Environment to approve, through an Individual Executive Decision Notice, implementation of the projects on the list marked 'IEDN' in the 'Approval' column of appendix B to the report, subject to the satisfactory outcome of public consultation, availability of funding and any other relevant considerations.
- 5. That the Cabinet Member for City Environment be authorised, in consultation with the Service Director, City Environment to approve, through an Individual Executive Decision Notice, the bringing forward of projects from appendix C to the report to appendix B to the report and thereafter to approve them for implementation during 2017/18 subject to the satisfactory outcome of public consultation, availability of funding and any other relevant considerations.
- 6. That it be agreed to receive further reports at the appropriate times in order to obtain the necessary authority to construct the projects marked 'Cabinet' in the 'Approval' column of appendix B to the report.
- 7. That the Director of Governance be authorised to serve all necessary notices in respect of the projects listed in appendix B to the report and, subject to there being no unresolved objections, make traffic regulation orders as required.
- 8. That the Director of Finance be authorised to enter into funding agreements with the various funding bodies to receive grant funding in respect of the projects included in the report.
- 9. That the delegation of authority to the Cabinet Member for City Environment and the Cabinet Member for Resources, in consultation with the Strategic Director for Place and Director of Finance to approve capital budgets for transport schemes upon receipt of a grant offer letter be approved.
- 1. That the expenditure and progress made in delivering the projects in the Transportation Capital Programme during 2016/17, as set out in appendix A to the report, be noted.
- 2. That the Council's continuing success in bidding for additional funding and delivering new projects through the Highway Maintenance Challenge Fund, the Local Pinch Point Fund, the Access to Growth Fund, the Managing Short Trips programme and more recently the National Productivity Investment Fund be noted.

10 Heath Town Regeneration Project

Councillor Peter Bilson referred to the report in the Supplementary Pack and informed the meeting that the update was an amendment to remove a reference to WV Living. The report sought approval for the amended delivery proposals for the Heath Town regeneration project to progress work across the estate and the delivery of new build homes. The Council would keep residents informed of progress as work on the project continued.

- 1. That the amended delivery proposals be approved for the Heath Town regeneration project through a combination of:
- a. direct development of the affordable units through the HRA (Housing Revenue Account),
- b. disposal of sites by competitive tender or through direct disposal with District Valuer valuations to private developers for market housing development.
- 2. That authority be delegated to the Cabinet Member for Housing and City Assets together with the Director of Governance or Strategic Director: City Housing to

agree the details of disposal of sites at Heath Town at a value to be determined by the District Valuer or by competitive tender.

- 3. That authority be delegated to the Cabinet Member for Housing and City Assets together with the Strategic Director: City Housing to agree the details of appropriation of General Fund sites within the Heath Town Masterplan area to the HRA for delivery of Council housing, at a value to be determined by the District Valuer.
- 4. That authority be delegated to the Director of Governance to execute legal agreements in respect of the Heath Town Regeneration as required.
- 5. That authority be delegated to the Cabinet Member for Housing and City Assets in conjunction with the Strategic Director: City Housing for the approval of any minor variations to the project required for its delivery.
- 6. That it be agreed to require that a minimum of 25% of the houses within the Heath Town development would be affordable and that the existing Multi Use Games Area (MUGA) and the Grosvenor Street open space would be upgraded.
- 1. That progress on Phase 1 of the demolition works and enabling works for Phase 2 of the demolition works be noted.
- 2. That improvements proposed for the green field at Grosvenor Street be noted.
- 3. That progress on Wolverhampton Homes' £35 million Investment Programme for the Heath Town estate be noted.
- 4. That the on-going discussions with Black Country Make Community Investment Company around providing access to a small site on a leasehold basis for the development of community build homes on the Heath Town estate be noted.

11 Long Term Empty properties back into use - proposed pilot

Councillor Peter Bilson presented the proposed pilot to further encourage the bringing back into use of long term empty residential properties. The pilot would build on effective work that had already been undertaken in this area. Recent media attention had reported that the Council was in possession of 2420 empty properties. It was clarified that this figure included privately owned properties, the Council currently owned 288 empty properties and was bringing properties back into use each year.

- 1. That the introduction of a 6-month pilot programme to further encourage the bringing back into use of long term empty residential properties be approved.
- 2. That the introduction of 2 pilot schemes of financial assistance be approved:
- a. Scheme 1, being the conditional offer of up to £500 financial assistance for legal/agents' fees connected with the sale of long term empty properties to encourage owners to sell
- b. Scheme 2, being the conditional offer of up to £500 to incentivise owners of long term empty properties to participate in the Private Sector Leasing Programme
- 3. That amendments to the Council's private sector housing assistance policy be approved to facilitate Scheme 1 and Scheme 2.
- 4. That the priority groups for this pilot programme be approved as being:
 - Priority Group 1 Unfurnished Properties listed as empty for more than 2 years.
 - Priority Group 2 Properties listed as empty for more than 2 years and furnished.

- Priority Group 3 Properties Listed as being empty for between 6 months and 2 Years
- Priority Group 4 Properties listed as empty with an exemption as the owner is either in care or probate had not been achieved
- 5. That it be agreed that the financial expenditure and impact of the pilot is kept under review and to accept a future report to Cabinet on the impact and effectiveness of the Schemes.

12 Adult Social Care Peer Challenge - Improvement Action Plan

Councillor Sandra Samuels presented the Improvement Action Plan that had been created following the Peer Challenge. The Council participated in the West Midlands Association of Directors of Adult Social Services regional sector led improvement programme of Peer Challenges as part of a collective commitment to continual improvement of adult social care services in the region. The very positive reputation of the City of Wolverhampton within the region and beyond had been noted and progress had already been made against the recommendations that had been received.

Resolved:

1. That the finalised Peer Review Action Plan and the final implementation stages of the Peer Review be agreed.

13 **People Directorate Commissioning Strategy**

Councillor Sandra Samuels presented the draft People Directorate Commissioning Strategy 2017-2021. The strategy had been updated and incorporated a family approach to commissioning services across the Council. The importance of partnership working between Adults, Children and Young People and Public Health directorates was emphasised as services often overlapped.

Resolved:

1. That it be agreed to receive and comment on the attached draft People Directorate Commissioning Strategy 2017- 21, direct any required further actions; and approve the issuing for consultation and engagement with stakeholders prior to request for Cabinet approval of a final draft on 19 July 2017.

14 Financial Support to Carers of Children Subject to Adoption, Special Guardianship or Child Arrangement Orders

Councillor Val Gibson sought approval for the updated policy for Financial Support to Carers of Children Subject to Adoption, Special Guardianship or Child Arrangement orders, the additional indicative cost and its implementation on 1 May 2017. The policy requires review to ensure that it is not only compliant to changes in regulations but also that it is compliant with recent case law and to ensure that the financial support for permanence orders is in sync with the allowances paid to foster carers. The proposed changes included areas such as the criteria for financial support and the requirement for carers to complete an annual financial statement. The policy aimed to target carers in need of the financial assistance and would mean an overall long term saving for the Council.

- 1. That the updated policy for Financial Support to Carers of Children Subject to Adoption, Special Guardianship or Child Arrangement orders be approved in line with the changes outlined within the report, and the implementation on 1 May 2017 also be approved.
- 2. That the additional indicative cost, which was estimated to be in the region of £440,000 per annum for the period the allowance was granted for, relating to Adoption, Special Guardianship or Child Arrangement orders be approved.

15 **Re-organisation of Educational Provision**

Councillor Claire Darke sought approval for the commencement of an informal consultation on the proposed merger of an infant and junior school and for delegated authority to decide on a formal consultation subject to the results. The merger would promote a closer working relationship and aim to promote a good standard of education for all children attending the schools.

- 1. That the commencement of informal consultation on the proposed merger of Springdale Infant School with Springdale Junior School be approved.
- 2. That authority be delegated to the Cabinet Member for Education, in consultation with the Assistant Director for School Standards, to consider the outcome of informal consultation on the proposed merger of Springdale Infant School with Springdale Junior School and to determine whether or not to proceed to formal consultation.
- 1. That the position at Christ Church CE Infant and Nursery School and Christ Church CE Junior School be noted.

The Cabinet is recommended to:

- Approve the declaration under the National Parks and Access to the Countryside Act 1949 (as amended) of that part of the Black Country Wyrley & Essington Canal Local Nature Reserve (LNR) which falls within the City of Wolverhampton administrative area as shown on Plan 1.
- 2. Authorise the City of Wolverhampton Council to enter into a Collaboration Agreement with the Canal & River Trust and Walsall Metropolitan Borough Council to manage the LNR for 21 years in accordance with the published Management Plan.

- 3. Authorise designation of the Wyrley & Essington Canal Site of Importance for Nature Conservation (SINC) as shown on Plan 2.
- 4. Receive a further report in 2020 to summarise progress made on delivering key actions in the Management Plan and to consider any apropriate updates or changes needed to the Management Plan.


1.0 Summary

1.1 This report recommends that Cabinet agree to declare a new Local Nature Reserve (LNR) in Wolverhampton, covering the Wyrley & Essington Canal and adjoining land owned by the Council, to enter into a collaboration agreement with the Canal & River Trust and Walsall Metropolitan Borough Council to manage the LNR appropriately for at least 21 years in accordance with the published Management Plan, and to designate the LNR in Wolverhampton as a Site of Importance for Nature Conservation (SINC).

2.0 Background

- 2.1 City of Wolverhampton Council, Walsall Metropolitan Borough Council and the Canal & River Trust have been working together for the past three years, in consultation with Natural England, to designate a new Local Nature Reserve (LNR) covering the Wyrley & Essington Canal and adjoining open space in Wolverhampton and Walsall. It was decided to consult on a draft Management Plan for the LNR and then amend the Management Plan in light of any comments made before making a formal declaration with the support of Natural England.
- 2.2 A Local Nature Reserve (LNR) is a publicly accessible site that is locally important for wildlife, education and enjoyment. LNRs are typically owned and managed by the local Council. This LNR will be unique as the majority is owned and managed by the Canal and River Trust, with areas of adjoining land owned and managed by City of Wolverhampton Council and Walsall Council. The part of the LNR which is located within Wolverhampton is shown on Plan 1.
- 2.3 An ecological survey was completed in 2013 covering the Wyrley & Essington Canal corridor in Wolverhampton. A Local Sites Assessment Report was produced which summarises the survey findings, provides detailed information on the wildlife value of the Canal corridor and justifies designation of the land as a Site of Importance for Nature Conservation (SINC). SINCs are protected from development under Policies in the adopted Local Plan.
- 2.4 Cabinet of 24 July 2013 agreed that new SINC designations could be made by Cabinet (or through delegated authority) where endorsed by the Local Sites Partnership (LSP) and following local consultation. The Birmingham and Black Country LSP endorsed the Wyrley & Essington Canal SINC designation on 19 June 2013 and public consultation has taken place as part of consultation on the LNR Management Plan. Therefore it is now appropriate for Cabinet to authorise the formal SINC designation alongside the LNR declaration. The boundary of the new SINC is shown on Plan 2.







3.0 Local Nature Reserve Consutation Process

- 3.1 Public consultation took place during 2016 on the details of planned habitat, access and signage improvement works for Council-owned land, as summarised in the Action Plan section of the LNR Management Plan. This consultation took place to support an ERDF Bid to help deliver the works (see Financial Implications section below). Residents living alongside the land concerned were contacted and raised a number of concerns relating to access and security, all of which were addressed in the final design for the works, and in the draft LNR Management Plan.
- 3.2 Public consultation took place on the draft LNR Management Plan and the proposed boundary of the LNR for six weeks between 13 September and 5 May 2017. Information was posted on the Council's website, a press release was issued and stakeholders, interested parties and owners of properties immediately adjoining the Council-owned parts of the LNR were directly consulted. Natural England, a statutory consultee, responded to formally welcome declaration of the LNR. There were five further responses from non-statutory consultees, all of which supported the LNR designation. These responses are summarised below, together with a Council response to the issues raised.

Summary of Consultation Response	Council Response
Support creation of the LNR and any works to improve unmanaged areas of woodland (which create a maintenance issue for adjoining gardens), subject to proper future maintenance of landscaped areas.	Noted. Management of woodland areas will be maintained, subject to budget constraints.
Support objectives in the Management Plan which seek to control and reduce the effects of antisocial behaviour. The weir on the canal between Devil's Elbow bridge and Moathouse Lane Bridge now has railings, which encourages people to walk on the weir and creates security issues.	Noted. The Canal and River Trust own and manage the area of land concerned. The weir was opened up and railings installed in 2004 to allow for safe inspection and maintenance of the weir. Removing the railings would cause health and safety issues, however the potential to limit access through landscaping measures will be investigated.
The LNR declaration is welcomed. A new public access to the Canal towpath should be created through the new open space forming part of the Former Jennie Lee Centre housing development, to compensate for loss of open space on this development site and the former Wednesfield High School site nearby.	There are currently two permitted accesses onto the canal towpath through the Jennie Lee development site. The potential to create an additional access through the new open space will be explored.
There are currently plans to enhance the City's canal network for cycling and walking, including	Agree that the type of lighting installed as part of towpath

the Wyrley & Essington towpath between Wolverhampton City Centre and Wednesfield. This may include installation of lighting which could have a negative impact on wildlife. Appropriate lighting solutions could be used to limit the impact on wildlife.	enhancement schemes should minimise impacts on wildlife. This could include installation of ground level, solar powered cats eyes lighting.
Welcome declaration of the LNR, after many years of campaigning. There should be no delays in making the declaration and implementing the Management Plan in future. The Canal is a great route for walkers and cyclists - the towpaths are safe to use and integral to health and well-being of the local area.	Noted.
The Canal is an important wildlife corridor and this status will be enhanced through the LNR declaration, however rats should be controlled. Angling is a popular sport and should continue. Water quality needs to be continually tested and improved.	The Canal & River Trust carry out on-going water quality monitoring and works to improve water quality, as reflected in the Management Plan.
The LNR will increase activity in the local economy, including tourist spend and boating activities. Tourist activities along the Canal, such as the Floating Markets, should continue. A counting device should be located at Wednesfield to help evidence the benefits the Canal brings to the local community.	Noted. The Canal & River Trust will consider monitoring methods.
Better information and signage is needed at key locations to make people aware of points of interest.	Agree. The funding secured for improvement works will cover key signage and information provision.
Partners should be encouraged to enforce dog litter and fly tipping regulations.	A number of habitat improvements actions in the Management Plan should help to reduce fly tipping in certain areas. Dog litter and fly tipping issues on CRT and Council land will continue to be addressed within current budgets. Only local authorities have statutory powers to be able to enforce dog, litter and fly tipping offences.

3.3 It is considered that no changes need to be made to the Management Plan in response to issues raised during the consultation.

4.0 Way Forward

- 4.1 Walsall Metropolitan Borough Council intend to declare the Walsall section of the LNR through Cabinet approval in July 2017, and the Canal & River Trust will approve the declaration at an Executive Team meeting during July. A Collaboration Agreement will then be made between the three partners, which includes a commitment to jointly manage the LNR for wildlife, education and enjoyment purposes for at least 21 years. A draft Collaboration Agreement is attached as Appendix 2 and it is anticipated that only minor changes may need to be made to the wording of this agreement. Following this, the Declaration will be confirmed by Wolverhampton and Walsall Councils, a formal declaration statement (see Appendix 1) and other information will be sent to Natural England and a notice will be published in the local press, in accordance with statutory requirements. It is then intended to organise a launch event in September 2017.
- 4.2 The new SINC designation will be added to the Wolverhampton Local Plan Proposals Map and advertised on the Council's website.
- 4.3 A report will be taken to Cabinet during 2020 to summarise progress made on delivering key actions in the LNR Management Plan and to consider any apropriate updates or changes needed to the Management Plan. This will give sufficient time for the programme of habitat, access and signage improvement works to be completed and for promotional activities to have been effective in increasing use of the LNR.

5.0 Financial implications

- 5.1 Parts of the LNR are in Council ownership and are managed as public open space or landscaping. A programme of habitat, access and signage improvement works on some of these sites has been developed to help deliver actions in the Management Plan. £60,000 of planning contributions have been secured and a bid for £59,000 of ERDF funding (the Black Country Blue Network bid) is under consideration to implement this programme. Works will take place over the period 2017-2019, subject to approval of the ERDF Bid and Capital Programme approvals.
- 5.2 Designation of the LNR may affect the maintenance regimes for Council owned sites, but this will be within the limitations of existing budgets. (ES/18052017/W)

6.0 Legal implications

6.1 The processes referred to in this report are required by the National Parks and Access to the Countryside Act 1949 (as amended). (LD/180517/A)

7.0 Equalities implications

7.1 A screening has been carried out for equalities implications and this concluded that a full Equality Analysis was not required for the recommendations of this report, as they do not involve a change to Council services, functions, policies or procedures.

8.0 Environmental implications

8.1 Declaraction of a new Local Nature Reserve in Wolverhampton will help to preserve, improve and increase public access to areas of nature conservation value in the City.

9.0 Human resources implications

9.1 This report has no human resources implications.

10.0 Corporate landlord implications

10.1 Parts of the LNR are in Council ownership and are managed as public open space or landscaping. Designation of the LNR may affect the maintenance regimes for these sites, but this will be within the limitations of existing budgets. Consultation has taken place with Corporate Landlord and Public Realm throughout the LNR consultation and designation process.

BLACK COUNTRY WYRLEY & ESSINGTON CANAL LOCAL NATURE RESERVE DRAFT COLLABORATION AGREEMENT

THIS COLLABORATION AGREEMENT is dated xx xxxxx 2017

BETWEEN:

(1) The Canal and River Trust ("the Trust")

(2) City of Wolverhampton Council ("the City Council")

Civic Centre, St Peter's Square, Wolverhampton, WV1 1RP

And

(3) Walsall Borough Council ("the Borough Council") [Address]

Whereas:

- (A) The Partners have agreed to the Project being carried out on Land belonging to the Partners, with the use of funding to be secured from various sources.
- (B) The Partners will be jointly responsible for managing and operating the Project pursuant to the terms of this Collaboration Agreement.
- (C) The Partners will allow the Partners and their authorised contractors to enter onto the Land to carry out the Project Works subject to the Partners complying with their obligations under this Collaboration Agreement.
- (D) The Partners have consulted Natural England which has given its consent to the establishment of the Land as a Local Nature Reserve.

1. **DEFINITIONS (the terms on the left shall have the meaning on the right)**

Funding	Any money secured by the Partners, singly or jointly, for the purpose of delivering the Project Outcomes as identified in the Management Plan.
Land	means the land shown defined as the Black Country Wyrley & Essington Canal Local Nature Reserve in the Management Plan and edged and shaded red on the Plans.
Plans	means the plans attached hereto entitled: Plan 1, etc.
Management Plan	means The Black Country Wyrley and Essington Canal Local Nature Reserve Management Plan June 2017 and any subsequent updates agreed jointly by the Partners
Partners	The Canal & River Trust, the City of Wolverhampton Council and Walsall Metropolitan Borough Council
Project	The Black Country Wyrley and Essington Canal Local

Project Documents	The Collaboration Agreement and the Management Plan
Project Outcomes	The outcomes set out in Appendix 4 of the Management Plan
Project Works	Such works identified in the Management Plan to be carried out on the Land to deliver the Project Outcomes

- 1.1. Word importing persons shall include corporations.
- 1.2. Reference to statute shall include the same statute as amended, varied, supplemented, consolidated or re-enacted at any time or any delegated legislation made under it.
- 1.3. Reference to clauses are to clauses of this Collaboration Agreement
- 1.4. Headings in this Collaboration Agreement have been inserted for convenience only and shall not affect its construction.

2. OBJECTIVES AND SCOPE OF THE COLLABORATION AGREEMENT

- 2.1. The Partners agree to jointly manage the Land as a Local Nature Reserve under the National Parks and Access to the Countryside Act 1949 (as amended) for a period of at least 21 years from the Date of this agreement and thereafter until determined by any Partner hereto giving to the other Partners twelve months notice in writing expiring at any time. The Partners agree to cooperate with each other and to use reasonable endeavours to ensure the success of the Project.
- 2.2. The Partners agree that they will (as the case may be) each perform and observe their respective obligations and commitments contained in the Management Plan with a view to ensuring the Project Outcomes are achieved and ensuring the long term success of the Project.
- 2.3. The Partners have agreed the Management Plan and will ensure that their activities in connection with the Project comply with the requirements as set out in the Management Plan. If and when the Management Plan is updated by the Partners, the primary aim of the Management Plan will continue to be to maintain and preserve the nature conservation features of the Land and public enjoyment of these features.
- 2.4. The objectives set out in this Collaboration Agreement are intended to be the understanding between them which outlines:
 - 2.4.1. the obligations between the Partners
 - 2.4.2. the process by which the Project Outcomes can be achieved;
 - 2.4.3. the process by which Funding will be allocated by the Partners;
- 2.5. This Collaboration Agreement must be read in conjunction with the Management Plan.

3. DURATION OF THE COLLABORATION AGREEMENT

- 3.1. This Collaboration Agreement will come into force on the date of this agreement and will continue in force until that date which falls 21 years from the Date of this agreement or, if later, the date the Partners discharge their obligations under this Collaboration Agreement.
- 3.2. Nothing in this document shall create any legally binding relationship among the Partners nor a partnership in law. The role of the partnership is advisory and its decisions will be applied by Collaboration Agreement and will not be enforceable on any party. This Collaboration Agreement sets out the manner in which the Partners intend to co-operate to ensure the delivery and subsequent maintenance of the Project.

4. **OBLIGATIONS**

- 4.1. The Partners shall not be required to give any assistance whether financial or otherwise in the management of the Project. However, the Partners will endeavour to allocate resources and Funding as available and appropriate to deliver Project Works throughout the duration of the agreement, in accordance with the terms of the Project Documents.
- 4.2. The Partners shall jointly monitor the Project and achievement of the Project Outcomes, pursuant to the obligations contained in the Project Documents.
- 4.3. Following the completion of the Project Works the obligations of each Partner shall be limited to maintaining the completed Project Works where they cross that Partner's land or are wholly located within it.

5. **AMENDMENT**

5.1 Notwithstanding any other of the Clauses in this Collaboration Agreement no deletion from, addition to, or variation of the Clauses shall be valid or have any effect unless agreed in writing and signed by the Parties.

6. CONTRACTS OF RIGHTS OF THIRD PARTIES ACT

6.1. This Collaboration Agreement does not create any rights enforceable by any person not a Party to it except that a person who is the permitted successor to or assignee of the rights of a Party is deemed to be a Party of this Collaboration Agreement.

7. **LAW**

7.1 This Collaboration Agreement shall be construed in all respects in accordance with English Law and shall fall within the jurisdiction of the English Courts. Nothing in these conditions shall prejudice any condition or warranty (expressed or implied) or right of remedy to which the Board are entitled in relation to the Project by virtue of statute or common law.
