1.0 Purpose

1.1 The Licensing Sub-Committee is required to consider the application by West Midlands Police for a Review of the above Premises Licence, following an Expedited Review.

2.0 Background

2.1 The current premises licence is attached at Appendix 1.

3.0 Expedited Summary Review Application

- 3.1 An application was received from the Chief Officer of Police for West Midlands on 28 January 2019 for an expedited review of the Premises Licence in respect of The Outback, 50 Queen Street, City Centre, Wolverhampton, WV1 3BJ.
- 3.2 A copy of the expedited review application can be found at Appendix 2 of this report.
- 3.3 The premises are situated in the St Peter's ward and a location plan is attached at Appendix 3.
- 3.4 A Licensing Sub-Committee hearing was held on 30 January 2019 to determine the interim steps to be applied to the Premises Licence pending the full review hearing. The Licensing Sub-Committee resolved to suspend the Premises Licence as the interim step.

4.0 Review Application

- 4.1 The notice of review has been properly served on all the Responsible Authorities. The Council has complied with the legislative process and displayed the appropriate notice at the premises and on its website as required, when the application for review was made.
- 4.2 Representations have been received from Trading Standards and The Licensing Authority as Responsible Authorities, and these can be found at Appendices 4 and 5 of this report.
- 4.3 The applicant for review, the Premises Licence Holder, and those who have made representations have been invited to attend the review hearing.

5.0 Financial implications

5.1 There are no direct financial implications associated with the recommendations in this report. No fee is levied for an Expedited Summary Review application. The fees and charges in relation to the Licensing Act 2003 are set by the Secretary of State. This was noted by the Licensing Committee on 24 January 2018. [MK/07022019/Y]

6.0 Legal implications

6.1 The Licensing Authority must consider the application for the review under Section 53A of the licensing act.

 - (a) Modify the conditions of the licence;
 - (b) Exclude a licensable activity from the scope of the licence;
 - (c) Remove the designated premises supervisor;
 - (d) Suspend the licence for a period not exceeding 3 months;
 - (e) Revoke the Licence.
- 6.6 In addition, regard shall be had to guidance issued by the Secretary of State under Section 182 of the Licensing Act 2003 and Wolverhampton City Council's Licensing Policy Statement. [LW/13022019/N]

7.0 Equalities implications

- 7.1 This report has human rights implications for both the premises licence holder and the residents from the local neighbourhood. Any of the steps outlined in Section 4 of this report may have financial implications for a licensee's business and livelihood and/or may have impact upon the day to day lives of residents living in close proximity to the premises.

- 1. A knife arch is to be placed at the front entrance door during all licensable activities. All patrons are to pass through it and upon indication from the arch that metal is detected, the patron is to be further investigated by SIA door staff with the use of an electric hand wand. All patrons shall be re-searched upon re-entry to the same standard. All patrons refusing to be searched will be denied access to the premises. If the knife arch is not operational, police will be informed of this fact and a repair timescale provided.
- 2. At all times when licensable activities are taking place SIA door staff shall be deployed from 22:00 hours with at least two in position at the front doors. Door staff numbers will be two for the first 100 patrons and 1 per 75 patrons thereafter.
- 3. All SIA door staff shall be in high visibility attire that fluoresces, and at least one door staff member shall operate a lapel cam system. If the lapel cam is not operational police will be informed of this fact and a repair timescale privided.
- 4. A briefing of responsibilities shall be given at the commencement of each tour of duty to door staff, and a record shall be kept endorsed by staff to say that they have received a briefing and understand their responsibilities.
- 5. At least one member of door staff shall be deployed to the external smoking area to make hourly checks for that area, which shall be recorded in the incident book.
- 6. At least one member of door staff shall remain outside the front of the premises for 30 minutes after close or until all customers have vacated the premises and the concourse area in front of the premises, whichever event occurs sooner.
- 7. At least one door staff member shall be basic, first aid trained on a six monthly basis.
- 8. There shall be detailed incident reporting to the police, overseen by the DPS. Either the DPS or another member of the premises management staff will contact West Midlands Police Licensing via email every Monday to report any incidents that have occured during the previous week and, where appropriate and as shall be agredd by both parties acting reasonably, an appointment shall be made with Licensing Officers to carry out such further review as the parties shall agree, acting reasonably, to be necessary, such as providing and reviewing together CCTV footage.

Police are defined as a responsible authority under the Licensing Act 2003 and as such have a statutory obligation to ensure that the licensed premises comply with the requirements of the act and the operating schedule relating to that venue.

Outback is a prominent building in the middle of Queens Street which is mainly business premises around but there are a small amount of flats/residencies above businesses on the street.

In December 2018 PS Reynolds held a meeting with the PLH, DPS and Abdul (the manager) to discuss the running of the venue and lack of responsibility taken by Abdul and the DPS Cheryl. There were numerous licence breaches and concerns around the safety of patrons attending and who had control of the premises.

It was agreed by Abdul that he would send weekly emails detailing events with performers and their full details in order for a risk assessment to be conducted.

Sgt Reynolds stressed that the venue were responsible for the patrons from their venue when outside and that the DPS needs to take a more active role in the running of the venue and upholding the licensing objectives.

It was agreed by all parties concerned that all issues raised would be adhered to.

Sgt Reynolds informed all parties that future breaches of their licence would result in action being taken against them.

PS Reynolds emailed Abdul on 22/1/19 outlining that her requests from the meeting in December were not being adhered to. No details of events planned had been communicated. PS Reynolds specifically requested details of the events being held the weekend of 25/26th January.

On 23/1/19 Abdul replied, listing DJ's, however failed to mention a specific performer that was deemed as high risk.

On Friday 25th January 2019 West Midlands Police received information that a performer from London would be at the venue and was "wanted" by police, and would need to be arrested.

WPC Churm emailed Abdul on 25/1/19 and enquired whether the performer was attending. It was only then that Abdul confirmed he would be at the venue at the with 3 members of his team.

Police Intelligence checks conducted, show that the performer would be classed as a 'risk' artist as he is an affiliated gang member in London.

Intelligence received by West Midlands Police indicated that gang members from Birmingham would be attending the venue to see the performer.

At 0422hrs on Saturday 26th January 2019 Police were called to a stabbing outside the venue.

The victim was from Birmingham, suffered 3 stab wounds to the back. Four males, of which 3 are known to be affiliated to a Wolverhampton gang have been arrested on suspicion of the serious assault.

All parties involved had been inside Outback, which clearly shows that the information received by West Midlands Police to be correct. This raises serious concerns that the venue had purposely withheld this information from police, knowing it to be a high risk event. This completely undermines the licensing objective of preventing crime and disorder and has resulted in someone being seriously harmed with a weapon on the streets of Wolverhampton.

Please provide as much information as possible to support the application (please read guidance note 3) On 5 May 2017 the manager Abdul and the DPS Cheryl attended Bilston Street Police Station whereby a meeting was held and an action plan was agreed. Action plan details: To fully cooperate with the police when they attend the venue to carry out licensing checks and carry out their duties. Knife arch in full working order at all times and this is to remain outside of the venue until ALL licensable activities are concluded. All persons who re enter the venue must be re-searched including the Arch and the wand. All persons to be searched with use of both a wand and must walkthrough the Knife arch The doorstaff are to remain outside until the concourse is clear, This is anytime where there is licensable activities and not just Friday and Saturday nights. A female member of doorstaff must be on duty in order to search female patrons.

In December 2018 PS Reynolds held a meeting with the PLH, DPS and Abdul (the manager) to discuss the running of the venue and lack of responsibility taken by Abdul and the DPS Cheryl. There were numerous licence breaches and concerns around the safety of patrons attending and who had control of the premises. It was agreed by Abdul that he would send weekly emails detailing events with performers and their full details in order for a risk assessment to be conducted. Sgt Reynolds stressed that the venue were responsible for the patrons from their venue when outside and that the DPS needs to take a more active role in the running of the venue and upholding the licensing objectives.

It was agreed by all parties concerned that all issues raised would be adhered to. Sgt Reynolds informed all parties that future breaches of their licence would result in action being taken against them.

PS Reynolds emailed Abdul on 22/1/19 outlining that her requests from the meeting in December were not being adhered to. No details of events planned had been communicated. PS Reynolds specifically requested details of the events being held the weekend of 25/26th January.

On 23/1/19 Abdul replied, listing DJ's, however failed to mention a specific performer that was deemed as high risk.

On Friday 25th January 2019 West Midlands Police received information that a performer from London would be at the venue and was "wanted" by police, and would need to be arrested.

WPC Churm emailed Abdul on 25/1/19 and enquired whether the performer was attending. It was only then that Abdul confirmed he would be at the venue at with 3 members of his team.

Police Intelligence checks conducted, show that the performer would be classed as a 'risk' artist as he is an affiliated gang member in London.

Intelligence received by West Midlands Police indicated that gang members from Birmingham would be attending the venue to see the performer.

At 0422hrs on Saturday 26th January 2019 Police were called to a stabbing outside the venue.

The victim was from Birmingham, suffered 3 stab wounds to the back. Four males, of which 3 are known to be affiliated to a Wolverhampton gang have been arrested on suspicion of the serious assault.

All parties involved had been inside Outback, which clearly shows that the information received by West Midlands Police to be correct. This raises serious concerns that the venue had purposely withheld this information from police, knowing it to be a high risk event. This completely undermines the licensing objective of preventing crime and disorder and has resulted in someone being seriously harmed with a weapon on the streets of Wolverhampton.

I wish to support the expedited review application made by West Midlands Police, on behalf of Trading Standards as a Responsible Authority.

The issues raised by West Midlands police show a blatant disregard to the licensing objective of preventing crime and disorder, by the Management of Outback. The management failed to inform the police (despite previous assurances) of who the performers were going to be, so a full risk assessment could be considered beforehand.

I understand one of the performers on the night in question was a direct Trading Standards matter I have to consider the licensing objective of Protecting Children from Harm. I have grave concerns that such performers as who is rising in popularity and currently number in the music charts with "attract a young audience. Viewers to 'You Tube' can see that young people are clearly attracted and wound up by this genre of music. There is no evidence that minors were in the venue on this occasion but two 15 year olds were arrested outside the premises following the serious assault. I believe that the Management of Outback by inviting such an artist to their premises is also risking the safety of young people and minors. I therefore agree that the premises licence should be reviewed.

I write on behalf of the Licensing Authority as a Responsible Authority. I write in support of the above review application made by Chief Constable of West Midlands Police. Representations are made against Crime and Disorder and Public Safety licensing objectives the failure of the current management of the premises to promote these objectives.

The premises licence holder, 1878 Pub Co Limited and the management of the premises have not demonstrated they are operating in accordance with their premises licence and therefore are not promoting the licensing objectives of Crime and Disorder and Public Safety.

On 28 January 2019, West Midlands Police submitted an expedited review application due to an event taking place at the premises which resulted in a member of the public receiving multiple stab wounds.

On 30 January 2019, the Licensing Sub-Committee determined interim steps were necessary and resolved to suspended the premises licence pending the full review hearing.

The Licensing Authority has great concern over 1878 Pub Co Limited and the management of the premises as from the evidence provided by the West Midlands Police, it is apparent that serious crime and serious disorder has occurred at the premises.

If Councillors are satisfied that illegal activities have taken place at the premises and are in breach of promoting the licensing objectives, the Licensing Authority would request the Licensing Sub-Committee ensure these issues are addressed by considering modification of the current premises licence in accordance with section 52 of the Licensing Act 2003 and guidance issued by the secretary of state under 182 of the Act together with City of Wolverhampton Councils Statement of Licensing Policy.

Councillors may conclude from the evidence given within the review application and at the hearing in order to promote the licensing objectives it is necessary to remove the current management, namely Cheryl Davis and Abdul Matli being the designated premises supervisor and the manager respectfully or modification of the premises licence to ensure the current management of the premises fully understands their roles and responsibilities in order to address Crime and Disorder and Public Safety licensing objectives.

The Licensing Authority fully supports the review application brought by West Midlands Police and concludes the above issues should be resolved in order to promote the licensing objectives of Crime and Disorder and Public Safety.
