Summary

On 18 October 2023, Cabinet delegated authority to the Cabinet Member for Job, Skills and Education, and the Cabinet Member for Resources, in consultation with the Director of Finance and the Director of Childrens services, to approve changes to the local funding formula for Schools including method, principles and rules adopted.

Recommendation for decision:

That the Cabinet Member for Resources, and the Cabinet Member for Job, Skills and Education, in consultation with the Director of Finance and the Director of Childrens Services approve individual 2024-2025 budgets for schools reflecting the changes in the local funding formula approved by Schools Forum.

1.0 Background

1.1 Although the government's intention is still to move towards the full implementation of a National Funding Formula (NFF) for schools, it is recognised that this represents a significant change and so Local Authorities are again required to set a local formula for

- 2024-2025. The Council is required to approve adjustments to the formula in line with the published guidance and recommendations from Schools Forum.
- 1.2 On 18 October 2023, Cabinet delegated authority to the Cabinet Member for Resources, and the Cabinet Member for Job, Skills and Education, in consultation with the Director of Finance and the Director of Childrens Services to approve proposed changes to the local funding formula including method, principles and rules.

2.0 Progress

- 2.1 The formula used to calculate the individual schools' budgets from the Schools Block of the Dedicated Schools Grant (DSG) was agreed and approved by Schools' Forum at their meetings in December 2023 and January 2024.
- 2.2 At its January meeting Schools Forum agreed to again implement a local formula which adopted all the NFF factors (adjusted using the government's area cost adjustment to adjust for local economic factors) with a Minimum Funding Guarantee of 0% and a gains cap of 2.57%. The growth fund was set at £1.3 million.
- 2.3 The Authority Pro-forma Tool (APT) for Schools Block DSG was submitted to the Department for Education (DfE) in January 2024, using the agreed local formula factors. Clearance was received from the DfE in February 2024, to confirm that the submission passed all the relevant checks.
- 2.4 Appendix 1 details the local funding formula as agreed by Schools Forum. The outcome of the APT, providing a school by school budget for 2024-2025 is provided in Appendix 2.
- 2.5 The table below shows a summary of the distribution of the Schools' block for 2022-2023.
