1.0 Purpose

1.1 The Licensing Committee is asked to consider the establishment of a Private Hire Drivers Association Focus Group.

2.0 Background

- 2.1 Wolverhampton Private Hire Drivers Association (WPHDA) is a recognised group representing private hire drivers. WPHDA are a member of the Private Hire Working Group and have attended most of the working group meetings since their inception. They have raised several issues with the Licensing Authority and have contributed to trade consultations at working group meetings.
- 2.2 In November of last year WPHDA held a protest drive on the ring road. Prior to the protest Licensing Services had offered to discuss the association's most recent concerns through the Private Hire Working Group. WPHDA stated they were unwilling to meet through the established working group as they did not wish to discuss their issues in the working group format, which includes operators as active members of the group.
- 2.3 Following consultation with the Chair, the Cabinet Member with responsibility for oversight of taxi licensing and officers from Licensing Services, it was not felt appropriate to bypass the well-established existing agreed arrangements and jeopardise the excellent relationships that have been fostered with the trade over several years simply because WPHDA had threatened to carry out a protest.
- 2.4 WPHDA held the protest and their request for a standalone focus group was considered at the Private Hire Working Group on 24 November 2016. There was no consensus at the working group. The majority of operators present were reluctant to agree to establishing a group solely for WPHDA, even if this were only for a short series of meetings. A minority of operators were comfortable with the establishment of such a group, provided the meetings were open for operators to attend and observe.

3.0 Proposal

- 3.1 In the absence of any consensus from the Private Hire Working Group officers from Licensing Services propose that the Licensing Committee approve the establishment of a Private Hire Drivers Association Focus Group, subject to the following conditions:
 - Any agreed issues between WHPDA and the representative of the Licensing Authority
 from the group will be reported back to the Private Hire Working Group for consultation
 before any formal consultation and/or being presented to the Licensing Committee.
 - The group will be established on a task and finish basis with a series of meetings and a timetable agreed in advance.
 - The meetings will not include private hire operators as active participants; however, they will be permitted to attend meetings to observe.
