1.0 Background

1.1 The purpose of the report is to consider the outcome of responses received during consultation and to approve circulation of the school term and holiday dates 2018-2019.

2.0 Options

- 2.1 It is the statutory responsibility of each Council to set term and holiday dates for maintained schools in its area. This is undertaken on an annual basis following consultation with interested groups.
- 2.2 Over recent years there has been discussion at a regional level, through the Regional Term Dates Setting Panel, as well as consultation between local teacher associations, other unions and schools to enable dates to be aligned with those of our neighbouring councils.
- 2.3 As a result of regional discussions two options were presented for consultation with schools and teacher unions. Option two illustrated a change to the standard pattern with a five-week summer holiday and an extended two-week Autumn half-term break.
- 2.4 The second option was presented as concerns had been raised about the length and demanding nature of the Autumn term causing stress and fatigue for students and pupils. It could also be beneficial in reducing the effects of such a long break on children's learning and the time which vulnerable learners lack access to services.
- 2.5 The following two options were chosen as the basis for wider consultation across Wolverhampton.

2.5.1 Option One – The standard pattern
