### **Summary of Meeting**

- Introduction of Local Authority Officers in attendance.
- The purpose of the meeting was explained.
- A paper was presented by Dawn Long.
- The proposal was explained by Dawn Long.
- Simon Lucas gave a brief summary of events to date commencing with the Bilston Urban Village (BUV) Supplementary Planning Document and provided the opportunity for the Governing Body to review the current plans and responded to Governors' observations/questions.

The following questions and comments were raised by Governors:

- A Governor enquired whether additional car parking provision would be made available to accommodate the additional cars that the proposed expansion may create.
- A Governor advised that representatives from the City of Wolverhampton Council Parking Services Team had previously visited the site to assess parking/traffic problems outside the school and that it was felt that everything possible was being done to improve safety outside the road safety school. Letters have been sent to parents/carers requesting consideration for the safety of pupils and residents when parking vehicles.
- A Governor asked whether staggered start/finish times could be adopted due to the additional pupils being Reception Class pupils.
- A Governor asked about extending the railings and creating a new crossing outside the school.
- A Governor enquired about the future of the site.
- A Governor asked whether the school could be expanded further once re-located onto the BUV site.

- A Governor asked how much new housing on BUV was included in the current proposal and was pupil yield taken into account when planning.
- A Governor asked what would happen if the new building was not ready for the planned academic year.
- A Governor raised concern that the straight-line distance for some pupils would increase.
- A Governor suggested raising parents/carers awareness via. an article in the School Newsletter.
- A Governor commented that the proposal was a positive move for the pupils, staff and the local area.
- A Governor commented that at the end of the process pupils and staff would be happy with the new building.
- Governors endorsed the proposal and commented that staff would be better placed to know all pupils in the school.

Dawn Long asked whether Governors had any other questions/comments – there were none.

A Governor thanked LA Officers for an informative presentation and agreed to encourage fellow Governors to respond to the consultation.

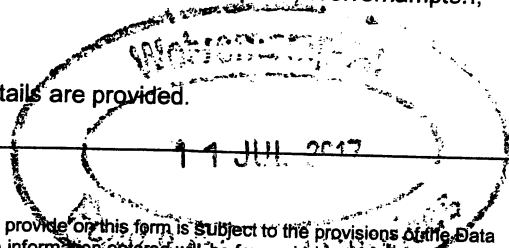

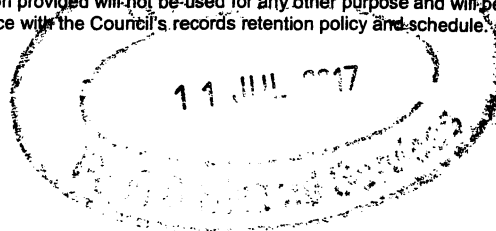

My house backs right onto the playground. The noise level is already very loud when the children are out playing - they constantly scream at the top of their voices. The younger children are the worst for noise. For someone who suffers with misophonia this is already a nightmare. If the reception admission were to double it would significantly increase my anxiety and depression. Also the number of cars that are parked outside our house, usually right across our drop-curb drive, is ridiculous. Again if the reception admission were to double this would roughly double the number of cars and there is just not room on these narrow streets - children are running across the street all the time and cars don't slow down round the bends. At some point one or more children are going to be seriously hurt or a fatality will occur just because you are trying to cram as many children into one school as possible. My father is severely sight impaired and has to use a cane as a walking aid - he can't use the cane when the school and nursery are picking up and dropping off because they park right on the pavements. He also can't see traffic approaching, the cars are always mounting the curb at speed using drop-curbs, this could easily knock down my father and injure him, just because the parents can't be bothered to walk the short distance to school, they \*have\* to drive and get as close as possible.

### **Summary of Meeting**

- Introduction of Local Authority Officers in attendance.
- The purpose of the meeting was explained.
- A paper was presented by Lisa Johnson.
- The proposal was explained by Lisa Johnson.

The following questions and comments were raised by Governors:

- The Headteacher stated that the main challenge would be around standards and managing the build alongside this
- It was recognised that the results were not great this year and that could ultimately influence an Ofsted Inspection outcome; they are due an inspection imminently
- A Governor was concerned if they had spaces then more hard to place children could be allocated to them in-year. In addition, if they needed to provide one to one support there would be a shortfall in funding in the first instance as the school would have to pay if the pupil was admitted post census. It would make the school vulnerable and finances would be impacted upon
- It was recognised that marketing may be needed should the school become 2 form entry but the Headteacher was concerned as they have good relationships with their neighbouring schools and wouldn't want to jeopardise that.
- Not a bad idea to put in place a 20mph zone outside the school as suggested by Parking Services
- It was recognised that there is no Crossing Patrol outside the school as the volume of traffic does not warrant one
- Governors stated that the on road parking is taken up by the residents of the flats and not the parents. The parents have to park in neighbouring roads such as Lime Grove. Parking a real hazard

- The Headteacher stated start and finish times may have to be looked at
- The Governors were informed that as part of planning processes sufficient space for staff parking would be looked at
- Headteacher pleased how the bulge accommodation was delivered and that it was in keeping with the rest of the school
- Staff had raised concerns to the Headteacher about the proposal including; the capacity of the boiler, coat pegs and windows (the staff want ones that can be opened manually) and the sliding doors are heavy to open and there are problems when grit gets in them.

Lisa Johnson asked whether Governors had any other questions/comments – there were none.

Governors thanked LA Officers for their attendance.
