PART II - EXEMPT ITEMS

Investment Presentations (Appendix 1)

The first of two presentations at the meeting gave an introduction to currency management and was presented by Record Currency Management. The firm was represented by Neil Record (Chairman) and Caroline Scollan (Associate Director – Client Liasion).

The presentation (booklet attached at Appendix 2) was designed to detail active currency management from an overlay perspective and from a pure stand-alone strategy, the latter approach being categorised as an "alternative investment".

Following the presentation and question period, the Chair thanked the representatives for their attendance at the meeting and they withdrew. Members noted that more formal manager presentations would be arranged in the Autumn.

The Sub-Committee then received a presentation from a representative of Goldman Sachs International which is part of the Goldman Sachs Group. The presentation centred on infrastructure, an asset class which typically lay within "alternative investments" although some funds placed it within "private equity" or "property". The Company was represented by Max Ramirez, a member of the Pensions and Insurance Strategy Group, who also circulated booklets "Infrastructure as an Asset Class" (Appendix 3) and "Infrastructure Case Studies" (Appendix 4). The presentation aimed to build Members' knowledge of the investment activity. Following the presentation and question period, the Chair thanked the Mr Ramirez for his attendance at the meeting and he withdrew.
