Exclusion of Press and Public

109 Resolved:-

<u>Licensing Act 2003 – Application for a Personal Licence</u> (Appendix 44)

The Chair introduced all parties and outlined the procedure to be followed. No interests were declared by Members.

The Licensing Officer briefly outlined the report submitted to the meeting and circulated to all parties in advance.

All parties were afforded the opportunity to question the Licensing Officer.

At this juncture Mr Jagpal outlined the reasons for his application, indicating that he was General Manager at a local hotel and believed that a Personal Licence was crucial to his employment. He now had the responsibility of a family and had abstained from drinking alcohol following the conviction in 2008. It was noted that he had attended an approved alcohol awareness course.

All parties were afforded the opportunity to question Mr Jagpal.

At this juncture, Inspector Affron outlined the objection to the application made by the West Midlands Police.

All parties were afforded the opportunity to question Inspector Affron. Inspector Affron advised that the objection had been made as a matter of principle, in view of the fact that Mr Jagpal's conviction would not become spent until September 2013 and was not based on any personal knowledge of the applicant.

Mr Jagpal and Inspector Affron were afforded the opportunity to make a final statement.

All parties, with the exception of the City Council's Solicitor and the Democratic Support Officer, withdrew from the meeting at this point.

Deliberations and Decisions

The Sub-Committee discussed issues which had been raised during discussion of the application for a Personal Licence. The Solicitor advised the Sub-Committee of the options available to them in determining this matter, in light of the written report and representations made at the meeting.

Re-Admission of Parties

The parties returned to the meeting.

Announcement of Decision

The Sub-Committee considered the representations of the West Midlands Police appended to the report of the Licensing Authority, which was circulated to all parties in advance of the meeting, together with representations made by Mr Jagpal and the Police Officer at the meeting. The Sub-Committee subsequently decided that he should not be granted a Personal Licence. They were of the view that, in this case, the granting of the Licence would undermine the prevention of crime and disorder licensing objective, in light of the fact that his conviction for a relevant offence will not be spent until 3 September 2013.

All parties have a right of appeal to the Magistrates' Court within 21 days of receipt of this decision.
