<u>Licensing Act 2003 – Review of a Premises Licence</u> <u>Empire Suite (Edda Lounge), Ward Street, Wolverhampton</u> (Appendix 9)

The Chair introduced the parties and outlined the procedure to be followed at the meeting. No declarations of interest were made.

The Section Leader (Licensing) briefly outlined the report submitted to the meeting and circulated to all parties in advance. The hearing had initially been scheduled for 5 December 2012. However, due to a Member of the Licensing Sub-Committee declaring an interest as the Premises was in his Ward and additional paperwork being submitted by the West Midlands Police, Environmental Health (Commercial) and the solicitor for the Premises Licence Holder, it was resolved to defer the hearing until today. The Officer advised that an application to vary the Designated Premises Supervisor (DPS) had been received on 20 December 2012 and that J Haye had been registered as the DPS with immediate effect.

The Premises Licence Holder arrived late to the hearing and Mr Campbell advised the Sub-Committee that she was unwell and therefore unable to remain throughout the meeting. He suggested, therefore, that the Designated Premises Supervisor could adopt the Premises Licence Holder's statement and answer any questions raised during the hearing. He indicated that Ms Phillip was actually suffering from the norovirus. Mrs Perry advised that the West Midlands Police would be unhappy with this proposal as the Designated Premises Supervisor was new to the position, was not present at all meetings with the Police and would not be in a position to answer all questions raised in respect of the Premises.

The Council's Solicitor, whilst being reluctant to advise a further adjournment, acknowledged that the Designated Premises Supervisor would not be in a position to answer questions. The Sub-Committee endorsed this view and it was:-
