The Director of Pensions responded that she might have to report back to the Committee about the staffing implications of the proposals. She undertook to pursue the request for worked examples relating to the new scheme.

Combined Governance Activity – June 2012 (Appendix 1/7)

The report provided an outline of the current issues being raised by the Local Authorities Pension Fund Forum, and the West Midlands Pension Fund's proxy voting activity for the quarter. The Director of Pensions responded to a question from Councillor Bateman about the involvement of the Fund in the Local Authority Pension Fund Forum. She indicated that this is an alliance of 55 pension bodies of which she is the Honorary Treasurer and that the Chair of the Pensions Committee attends their business meetings. Councillor Reynolds asked to be provided with more information about the Research and Engagement Report-Annual Summary (LAPFF Minutes-21 March 2012), particularly in relation to shale gas fracking.

UK Annual Property Review (Appendix 1/8)

The representatives responded to questions raised by Members. A discussion took place regarding the property portfolio, including issues such as the number of Farms owned by the Fund and the geographical spread of properties. Resolved:-

Graeme Johnston, Senior Investment Consultant with Hymans Robertson, submitted the review and indicated that it will be considered in more detail by the Investment Advisory Sub-Committee at its forthcoming meeting on 4 July 2012.
