<u>Pensions Member Services Management Report from 1 March – 30 April 2012 (Appendix 1/1)</u>

New Member Information (Appendix 1/2)

The Director of Pensions referred to a forthcoming training session for Committee Members on 24 July 2012, which would provide in-depth guidance on issues such as governance, investments and retirements and pension benefits. She added that further dates could be arranged as necessary and she also intended to organise a training session for Joint Consultative Panel Members.

Malcolm Cantello (UNISON) suggested that representation by Trade Unions on the Investment Advisory Sub-Committee be increased to 3. Martin Clift (UNITE) advised that it was customary for a retired Union representative to observe meetings of the Sub-Committee and that this place has been held by Ian Smith for a number of years. He suggested therefore that there is currently a vacancy for a trade union representative on the Sub-Committee.

6 Resolved:-

- (a) That the report, providing a brief outline of the West Midlands Pension Fund, the management arrangements and special role of Committee Members in discharging their functions associated with relevant pensions regulations and legislation, and clarifying future training requirements, be noted.
- (b) That the Pensions Committee be recommended to increase the number of trade union representatives serving on the Investment Advisory Sub-Committee to 3, thereby preserving the custom of having a retired Trade Union representative at Sub-Committee meetings.

Corporate Governance Activity – June 2012 (Appendix 1/4)

It was noted that the Local Authority Pension Fund Forum had recently given consideration to the issue of shale gas fracking and Councillor Reynolds suggested that in cases where the Fund makes an ethical stance, this should be communicated to appropriate and interested organisations. The Director of Pensions referred to the work of LAPFF, adding that she regularly attends meetings along with the Chair of the Pensions Committee. She added that some of this activity and topics considered by the Forum could be added to the Fund's website if this was considered appropriate. The Director also responded to a question about the current Chair of the Forum.
