S106 Affordable Housing Contributions

- Used for new build affordable housing or purchase from the market, then allocated through Homes in The City, choice based lettings system.
- Committed sums £110,000 on housing purchased July 2020.
- Uncommitted sums £1,396,878.
- Four new houses to be built during 2021/2022 £690,000.
- Purchase of two properties in progress c.£265,000.
- Three properties are in the process of viewing, valuing and negotiating a purchase - c£365,000 plus stamp duty/legal fees.





S106 Transportation Contributions

- Highway/junction improvements, lighting schemes, road safety improvements and contribution to larger corridor improvements.
- Goodyear sites £392,035 contribution to the A449 corridor improvement scheme.
- Wobaston Road site £100,000 contribution to signal improvements.
 - Land at Ward St £60,000 contribution to road safety scheme.
 - Pantheon Park, Wednesfield Way £90,000 contribution to the Willenhall Road/Neachells Lane/Moseley Road junction improvements.
