Summary

This report provides an update on the High Needs block (HNB) of the Dedicated Schools Grant (DSG) 2022-2023 and seeks approval to allocate the funding in accordance with the guidance issued by the Education and Skills Funding Agency.

1.0 Background

- 1.1 The high needs funding system supports provision for children and young people with special educational needs and disabilities (SEND) from their early years to age 25, in line with statutory duties under the Children and Families Act 2014.
- 1.2 In December 2021, the Department for Education announced the provisional High Needs Block Grant Funding for 2022-2023.

2.0 High Needs Block Allocation and Budget requirement 2022-2023

2.1 As shown in the table below, the initial 2022-2023 HNB funding allocations show that Wolverhampton City Council will receive £46.16 million after deductions. This includes an additional allocation of £1.86 through the Health and Social Care Levy. This represents an increase of £5.46 million from the 2021-2022 allocation.

- 2.2 The current forecast expenditure against the High Needs Block in 2021-2022 is £42.10 million, which will result in an in-year overspend of £1.40 million and a carry forward overspend of £1.73 million. The Council will be required to put together a plan to recover this overspend from future underspends over the medium term. This plan will be in consultation with Schools' Forum.
- 2.3 The table in appendix 1 shows the detailed forecast budget requirement for 2022-2023 based on current data with growth built in where required to account for forecast increases in student numbers. There is naturally some risk around this and the forecasts will be monitored closely with Schools' Forum being updated of any significant changes to forecasts.
- 2.4 The forecast expenditure requirement for 2022-2023 is £45.50 million. This would result in an underspend against the overall budget allocation of £0.66 million, meaning the underspend could be used to partially recover the forecast overspend against budget in 2021-2022, and that the overall deficit would have reduced to £1.07 million at the end of 2022-2023.

3.0 Place Funding

- 3.1 The place funding for Pupil Referral Units and Special Schools remains unchanged at £10,000 per agreed pupil place funding, plus top ups based on pupils assessed needs.
- 3.2 High Needs Units within mainstream schools continue to be funded at £10,000 per unoccupied place and £6,000 plus the Age-Weighted Pupil Unit (AWPU) calculated in the

- local funding formula per agreed place that is occupied, plus top up funding where occupied.
- 3.3 Pupils in mainstream education do not attract specific place funding through the High Block but will continue to receive top up payments from the Local Authority for each occupied place, based on pupil's assessed needs.
- 3.4 Place funding budgets for 2022-2023 are based on the known levels of commissioned places along with planned new capacity to meet demand.

4.0 Matrix (Top Up) Funding

4.1 The High Needs Review Group are undertaking a review of the banding matrix as an assessment of individual pupil needs. This is a complex process involving consultation and the aim is to have the new top up funding arrangements in place for financial year 2023-2024. The current matrix band unit rates will remain unchanged from 2021-2022 and are shown as Appendix 2.

5.0 Additional Changes to 2022-2023 High Needs Block Budget

- 5.1 In addition to increasing the place and top-up funding the following changes have been made to the High Needs Block budget for 2022-2023.
 - Increases to cover pay awards and increments to Council staff
 - Growth for projected in-year additional placements
 - Predicted increase in EHCPs (and therefore SEN top ups) across the City
 - Increase to Tri-partied funding to partially cover reduction in Central Schools Services Block

6.0 Settings with High incidence of SEN

- 6.1 As in previous years, the Local Authority will retain funding to support schools that have a higher-than-average number of pupils with SEND. It is proposed that the criteria for support used previously be maintained for the 2022-2023 allocation.
- 6.2 In order for a school to be eligible for support from this fund they will need to satisfy **two** criteria:
 - Low Prior Attainment: The percentage of pupils attracting LPA within the school is more than 10% below the average for that sector

or

• Deprivation: The percentage of pupils attracting Deprivation within the school is more than 10% below the average for that sector

and

 Statements more than £6000: Where the number of Low Incidence High Cost (LIHC) pupils is more than 5.0% above the average for that sector.

7.0 Education Functions

7.1 At its January 2022 meeting Schools' Forum agreed that the 2022-2023 rate for Education Functions would be £31.45 per pupil. The Local Authority is proposing to increase this to £36.49 to cover the 50% reduction in the School Improvement and Brokering Grant. The Local Authority proposes no change to the previously approved multipliers of 3.75 for PRUs and 4.25 for Special Schools resulting in per place contributions of £136.84 and £155.08 respectively.

Summary

This report provides a summary of the Early Years funding block of the Dedicated Schools Grant, as illustrated in the Dedicated schools grant (DSG): 2022 to 2023 announcement made by the Education and Skills Funding Agency (ESFA) in December 2021.

1.0 Background

- 1.1 The Department for Education (DfE) introduced a National Funding Formula for Early Years (EYNFF) in 2017, and Schools' Forum agreed to wholly adopt the formula from its onset.
- 1.2 The hourly rate applied to City of Wolverhampton Council for three- and four-year-olds has been increased from £4.82 per hour in 2021-2022 to £4.99 per hour in 2022-2023.
- 1.3 An additional supplement has been made available for maintained nursery schools by way of a specific grant, and this grant continues to be made available for 2022-2023.

2.0 Proposals for 2022-2023 hourly rates

2.1 It is proposed that the £4.99 per hour allocated to Wolverhampton for universal three- and four-year-olds' funding will be utilised as shown in the table below. The rates for 2021-2022 are also shown for comparison.

- 2.2 Local Authorities are expected to "pass-through" a minimum of 95% of this hourly rate funding to providers and as the SEN Inclusion and Deprivation are passed through to providers the pass-through rate of this formula will be 99.2% in 2022-2023. The increase to four pence per hour will result in estimated total income to the Council of £112,000 per annum, whilst the forecast 2022-2023 cost of the Early Years service is £445,000 (including overheads). Whilst the Council will be required to move further towards funding the Early Years support service through the Early Years DSG Grant, it is mindful of the need to pass as much funding as possible to providers and therefore this will be a gradual process in consultation with Schools' Forum.
- 2.3 The table below sets out the proposed hourly rates for Early years funding in 2022-2023:

As noted above the Deprivation and Inclusion funding is passed to settings in addition to the base rate for three- and four-year-olds.

2.5 2022-2023 Early years block allocations are provisional and based on Schools, Early Years and Alternative Provision autumn census data 2021.

3.0 Disability Access Fund

3.1 Disability Access Fund (DAF) is distributed at a rate of £800 per eligible pupil. If a pupil attends more than one setting using their free entitlement, the parent must nominate the main setting to receive the supplement. If a pupil moves from one setting to another after the DAF has been paid, the new setting will not receive the grant for this pupil until the anniversary of the initial payment has been reached. There are no amendments to the distribution of this fund, as it is clearly defined by DfE and DWP eligibility criteria.

4.0 Maintained Nursery School Supplementary Grant

4.1 The maintained Nursery School Supplementary grant continues to be available in 2022-2023 and the hourly rate in 2022-2023 is £2.93 and the total for allocation is £919,391. This will be distributed in full to maintained Nursery settings.

5.0 SEN Inclusion Funds

- 5.1 Each Local Authority is required to have special educational needs (SEN) Inclusion Funds for all three- and four-year-olds with SEN who are taking up free entitlements, regardless of the number of hours taken. These funds are intended to support local authorities to work with providers to address the needs of individual children with SEN. This fund also supports local authorities to undertake their responsibilities to strategically commission SEN services as required under the Children and Families Act 2014.
- 5.2 SEN Inclusion funds are targeted at children with lower level or emerging SEN. Children with more complex needs and those in receipt of an Education, Health and Care Plan (EHCP) continue to be eligible to receive funding via the high needs block of the DSG.

1.0 Introduction

- 1.1 As part of introducing the National Funding formula the Department for Education (DfE) introduced a fourth block of funding within the Dedicated Schools Grant (DSG): the Central School Services Block (CSSB). This is to ensure local authorities can continue to carry out their important role in supporting the provision of excellent education for all children of compulsory school age.
- 1.2 CSSB funds local authorities for the statutory duties that they hold for both maintained schools and academies. It brings together:
 - Funding for ongoing responsibilities such as admissions, previously top-sliced by each local authority from its Schools Block allocation as centrally retained duties element, and Education Services Grant (ESG) services and;
 - Residual funding for historic commitments, previously top-sliced by the local authority from the Schools Block as centrally retained element.
- 1.3 A link to the policy document which sets out the background and principles of the new National Funding Formula for schools can be found in the background papers section.
- 1.4 Further detail on schools funding arrangements for 2022-2023, along with the Operational Guidance, can be found in the background papers section.
- 1.5 This paper covers arrangements for CSSB in 2022-2023. It sets out the City of Wolverhampton Council's funding allocation and presents the planned expenditure for decision.
- 1.6 Schools' forum approval or consultation is required each year to confirm the use of the CSSB.

- 2.1 The table above sets out the 2022-2023 DSG Central School Services Block received by the City of Wolverhampton Council. It also summarises a list of proposed budget allocations to be spent from CSSB for 2022-2023.
- 2.2 The total CSSB grant funding has decreased from £2.09 million in 2021-2022 to £2.02 million in 2022-2023. The grant funding for Historical commitments has been reduced by 20% which equates to a reduction of £97,280, whilst there has been an increase in funding for ongoing responsibilities in the region of £27,866. The increase in funding for ongoing responsibilities has been allocated to meet increased costs related to school admissions, servicing of the Schools Forum and Licences. In addition, it is proposed to extend the funding of the safeguarding officer within the MASH until the end of 2022-2023 to allow a full analysis of the effectiveness and possible funding going forward. Schools Forum is asked to approve the 2022-2023 budget allocations for the ongoing responsibilities totalling £1,634,806.
- 2.3 Copyright licensing the DfE purchase a single national licence managed by the Department for all state funded schools in England, covering 10 individual licences which includes:
 - a. CLA (Copyright Licensing Agency)
 Based on two rates: 5 to 15 (£1.73) and 16+ (£4.19).
 - b. SPML (School Printed Music Licence)
 Flat rate (£0.45), based on total number of pupils, 5 to 16+.
 - c. NLA (Newspaper Licensing Agency)
 Flat rate (£0.03964), based on total number of pupils, 5 to 16+.
 - d. ERA (Education Recording Agency)

 Based on two rates: Primary (£0.51) and Secondary (£1.06)

 Primary rate includes under-5s (this is reflected in the lower rate for the licence). Primary rate is also charged for special schools and PRUs/AP. Secondary rate is used for All Through schools.
 - e. PVSL (Public Video Screening Licence Filmbank Distribution Ltd.)
 Based on a single, flat rate per school (£138.20), including discount.

f. MPLC (Motion Picture Licensing Company)

Based on a single, flat rate per school (£78.44 for 2022 to 2023), including a 10% discount.

g. PPL (Phonographic Performance Ltd.)

Operates on a banding system according to the number of pupils in the school. Rate is £80.78 for 0-200 pupils, rising by £13.22 for every 50 additional pupils (rounded up).

h. PRS (Performing Right Society Ltd.)

Operates on a banding system according to the number of pupils in the school. Rate is £88.11 for 0-200 pupils, £98.36 for 201-250 pupils, and then rising by £13.95 for every 50 additional pupils (rounded up).

i. MCPS (Mechanical Copyright Protection Society Ltd.)

Based on a single, flat rate per school (£249.66)

j. CCLI (Christian Copyright Licensing International)

Based on a simplified banding system according to size of school and whether primary/secondary, with varying discounts applied. There is no charge for nurseries. The charges per school are:

- 2.4 ESG Services cover the retained duties element of the old Education Services Grant which Local Authorities (LA) used to part fund statutory services they provide to all schools including academies. These services include statutory and regulatory services such as preparation of the DSG budget, and elements of the Directors' time, Educational Welfare and asset management of the LA's capital programme.
- 2.5 Historical commitments approved by the ESFA are for:
 - a. Tri-partied budget of £358,400 is the contribution to the costs of funding arrangements shared between Education, Social care and Health for looked after children.
 - Termination costs of £30,720 supporting the costs of historical agreements for severance costs for staff as part of the school rationalisation and reorganisation.
- 2.7 The DfE requires that Schools' Forum approve the use of the CSSB for the purposes shown above.

3.0 Impact

3.1 The allocation of CSSB resources has a major impact on the Local Authority's ability to deliver its desired outcomes for all Wolverhampton's schools and as such has implications for all areas within the Education Service.

1.0 Background

1.1 This report confirms the final allocations of the Schools Block budget for financial year 2022-2023.

2.0 Schools' Block Funding

2.1 In December 2021, Schools' Forum agreed to continue to use local funding factors as per the national funding formula and apply the recommended Minimum Funding Guarantee (MFG) rate of 2.00% with no cap rate and to retain a growth fund, utilising the residual funds after applying the agreed formula rates.

2.2 Application of these agreements resulted in £235.52 million to be distributed through the funding formula, as illustrated in the following table. Following January's Forum meeting, the planned local formula and resulting allocations were submitted to and approved by the ESFA. Appendix 1 shows the allocations at individual school level. The Growth Fund carried forward balance in 2021-2022 is projected as £1.96 million and the allocation to the Growth Fund for 2022-2023 is 0.47 million, which is in line with the forecast required amounts for 2022-2023.
