On Tuesday 28th November 2023 Debra Craner Section Leader of Wolverhampton City Council Licensing Department has shown me CCTV footage of Canalside bar and Grill, Castlesroft Lane, Wolverhampton dated 4th November 2023. Debra and her team have obtained the CCTV following a complaint in relation to Canalside Bar and Grill. This footage shows the inside of this premises and an event that is taking place. CCTV shows a number of cameras from around the premise this included part of the bar area, a space which people were dancing in and a seating area. During this footage I observed there was a child on the dancefloor at 2258hrs, music still being played at 2307 hrs and at 2310hrs people were still stood around on the dance floor. The CCTV then stops. I then viewed CCTV starting from 0016hrs showing a customer at the bar which what is believed to being served a drink.
