The Statutory Licensing Sub-Committee is recommended to:

1. Consider an application by West Midlands Police for a review of the above Premises Licence, following an expedited review.

1.0 Purpose

1.1 The Statutory Licensing Sub-Committee is required to consider the application by West Midlands Police for a Review of the above Premises Licence, following an Expedited Review.

2.0 Background

2.1 The current premises licence is attached at Appendix 1.

3.0 Expedited Summary Review Application

- 3.1 An application was received from the Chief Officer of Police for West Midlands on 11 October 2019 for an expedited review of the Premises Licence in respect of Banjul, 30 Queen Street, Wolverhampton, WV1 3JW
- 3.2 A copy of the expedited review application can be found at Appendix 2 of this report.
- 3.3 The premises are situated in the St Peter's ward and a location plan is attached at Appendix 3.
- 3.4 A Statutory Licensing Sub-Committee hearing was held on 15 October 2019 to determine the interim steps to be applied to the Premises Licence pending the full review hearing. The Statutory Licensing Sub-Committee resolved to suspend the Premises Licence as the interim step.

4.0 Review Application

- 4.1 The notice of review has been properly served on all the Responsible Authorities. The Council has complied with the legislative process and displayed the appropriate notice at the premises and on its website as required, when the application for review was made.
- 4.2 Representations have been received from the Licensing Authority and can be found at Appendix 4 of this report.
- 4.3 The applicant for review, the Premises Licence Holder, and those who have made representations have been invited to attend the review hearing.

5.0 Financial implications

5.1 There are no direct financial implications associated with the recommendations in this report. No fee is levied for an Expedited Summary Review application. The fees and charges in relation to the Licensing Act 2003 are set by the Secretary of State. This was noted by the Licensing Committee on 20 March 2019. [KP/30102019/P]

6.0 Legal implications

6.1 The Licensing Authority must consider the application for the review under Section 53A

of the Licensing Act.

- 6.2 The Licensing Sub-Committee is asked to determine the review under Section 53A(2)(b) in accordance with Section 53C of the Act. The licensing authority must hold a hearing and consider the application for review and any relevant representations.
- 6.3 The Sub-Committee must consider what steps (if any) should be taken to secure the promotion of the licensing objectives.
- 6.4 The four licensing objectives are:
 - The prevention of crime and disorder;
 - Public safety;
 - The prevention of public nuisance; and
 - The protection of children from harm.
- 6.5 The steps that may be taken by the Sub-Committee on a full review are:
 - (a) Modify the conditions of the licence;
 - (b) Exclude a licensable activity from the scope of the licence;
 - (c) Remove the designated premises supervisor;
 - (d) Suspend the licence for a period not exceeding 3 months;
 - (e) Revoke the Licence.
- 6.6 In addition, regard shall be had to guidance issued by the Secretary of State under Section 182 of the Licensing Act 2003 and Wolverhampton City Council's Licensing Policy Statement. [SH/17102019/A]

7.0 Equalities implications

- 7.1 This report has human rights implications for both the premises licence holder and the residents from the local neighbourhood. Any of the steps outlined in Section 4 of this report may have financial implications for a licensee's business and livelihood and/or may have impact upon the day to day lives of residents living in close proximity to the premises.
- 7.2 Article 8(i) of the European Convention of Human Rights provides that everyone has the right to respect for his/her private and family life and his/her home (which includes business premises). Each member of the door team is required to signe a paginated record book at the commencement and completion of their duty providing name, address, badge number and date of birth. This book to be provided to any member of a responsible authority upon request.

Door supervisors shall be required to maintain a paginated record of all incidents stating date, time, nature of incident and action. The record will be maintained at the premises for one calender year following the date of the last entry.

All patrons to be searched upon entry and re-entry. Hand held metal detector wands should be used to ensure a full search has been completed. Females to be included in search. Any prohibited items should be logged and dealt with accordingly.

Internal and external CCTV to be installed and maintained, to the accepted standard of a West Midlands Police Crime Reduction Officer. The system needs to be of evidential quality with sufficient cameras located appropriate positions so that recordings of all customer-related areas inside the premises and thw hole area directly outside the premises are constantly made whilst the premises is open. Recordings to be retained for 31 days and at least one member of staff trained to use the system should be on duty at all times. Recordings to be made available to any officer from any responsible authority at the earliest opportunity.

The manager/representative of the premises will be a member of Pubwatch or similar trade based organisation in Wolverhampton.

Staff will be trained in their responsibilities with respect to Licensing as part of their induction programme and refresher training will take place regularly. This ongoing training shall be documented and made available for any officer of responsible authority upon request.

At least one personal licence holder to be on duty at any time that the premises are open.

The premises will be part of a radio link communication for the city centre retail/licensed premises.

On Wednesday 25th September 2019 Wolverhampton Licensing Department received an email from the Banjul email account, at 1704hrs detailing a list of DJ's who would be performing from 11/10/19.

West Midlands Police conducted risk assessments and on the 26th September 2019 were made aware of an event at the premises on the 4th October 2019 with one of their resident DJ's for his birthday. The event was not a private function and tickets and booths were available to book.

WPC Churm requested, via email that a risk assessment for the new Friday night events, to include the birthday party, was forwarded, that details regarding tickets/payment on the door were required and for a list of DJ's for the 4th October.

On the 29th September 2019 an email was received from detailing a number of issues that had been highlighted in previous emails regarding a request for a variation to the

highlighted in previous emails regarding a request for a variation to the licence, concerning a number of issues, including searching, that was requested back in September 2018. There was no information regarding the DJ's on the 4th October and no risk assessment.

On Saturday 5th October 2019 at approximately 0330hrs an incident occurred, within the premises, whereby a male has been slashed with what he believes is a knife by an unnamed male. The injured party stated that two unnamed females have been arguing, he has intervened and then been approached by an unnamed male who has slashed him hitting him on the head with a knife, causing blood to run down his face, over his eye and further lacerating his chest causing a wound of approximately 15-20 cms in length and 5-6 cms deep. The injured party was then taken to New Cross Hospital whereby he was treated for his injuries. Staff at New Cross contacted West Midlands Police to report the injuries and officers attended to ascertain the facts of the incident. This is the third incident in 12 months at this premises since opening.

There have been so many attempts by West Midlands Police to work with staff at the venue, liaising with DPS' and PLH's, conversing with solicitors on behalf of the premises, all to no avail. The venue opened around 21st September 2018 and it was observed that no searches were being conducted by the security firm, who were later sacked by the premises.

On the 29th September 2018 there was an incident outside the venue, involving patrons from within the premises, gang nominals and multiple stabbings occurred. This alone could have been enough for WMP to have brought the premises before the Committee in an expedited review as the incident was serious crime and disorder. WMP felt that as a new venue, we could mediate with the DPS/PLH with a view to ensuring that the incident was isolated and that there were the right policies and procedures put into place by the premises. WMP arranged a meeting with the DPS and later attended the venue immediately following the event to discuss licence conditions. It was discussed that the licence would need to be varied and more conditions implemented. The premises had approached a solicitor to act on their behalf

and apply for the variation. WMP conversed with said solicitor and a number of conditions were agreed between WMP and the solicitor. This was never progressed due to the solicitor being unable to contact the premise licence holder. WMP continued to communicate with the PLH to address this matter and to date the minor variations have not been applied for.

There was a further incident in December 2018 whereby known gang members attempted to rush the door.

On 5th October 2019 a stabbing occurred at the venue, the third incident, as detailed above. It is the belief of WMP that even if the requested conditions had been applied to the licence via a minor variation this incident would still have happened.

We can justify this comment from the email correspondence received dated 29th September 2019 whereby has stated 'We have a more strict search policy than any other club or bar in town' and 'We have continued with only using plastic glasses after advice from yourselves for the event back last year' and 'We follow any requests that have been required of us like a required amount of security guards. Bottles to booths only. Plastic cups/no glass etc. We have never had any issues.'

These comments are untrue.

- If the strict search policy of patrons going into the venue had been conducted a knife/bladed article would not have been inside the venue, therefore this incident would not have happened.
- Empty glasses were strewn in booths on the sides and on the floor and on the bar when WMP attended on 8th October.
- There have been previous issues at the premises, as detailed above. All of the incidents have involved known gang members from Wolverhampton and Birmingham.

The below claims were made in the same email;

- -Every night were open we have a operating airport style knife arch
- -A guard at the door has a body cam running constantly. Not just during incidents!
- -We have hand held metal detector wands
- -A female guard to search bodies and bags of females
- -We upgrade security for any busy nights or events yourselves think are high risk, to any required numbers.

WMP attended the premises on 8th October to view CCTV and within the premises saw a number of glasses that were dirty, clearly used around the club and on the bar. A broken wine glass was seen on the floor of one of the booths, which was pointed out. was clearly annoyed at this and a number of other issues, such as the clear breach of policies that should have been adhered to. These included the dress code, as people were seen wearing t-shirts, trainers, man bags and the failure to close the venue on time A lack of camera coverage within the club was discussed and on viewing

CCTV WMP believe that the incident occurred down by the DJ booth, whereby WMP were told that the cameras in that part were not working. No reason could be given as to why or how long this camera had not been working.
It is the opinion of West Midlands Police that this incident should have been avoided. The venue claimed they had implemented a strict search policy, searching of all persons entering and re-entering, yet a knife was still permitted into the venue which resulted in a member of the public receiving injuries. This incident was not reported by the venue, with one of the PLH's seen dealing with the group of males who would have been aware of the injury or at least the blood. It is West Midlands Police position that the venue have failed to uphold the licensing objective of Preventing Crime and Disorder.

I am a Superintendent in West Midlands Police.

I am giving this certificate because I am in the opinion that the procedures under the Licensing Act are inappropriate in this case because the standard review procedures are thought to be inappropriate due to the seriousness of this crime and disorder, and the serious management failings of the premises concerned.

The level and seriousness of this incident in terms of the crime and disorder warrant the use of this power. I have considered the use of the normal review procedure but I do not feel this would be appropriate in these circumstances due to the above reasons and the fact that to maintain the licensing objective of preventing crime and disorder the normal review procedure would not be sufficient.

The concern of West Midlands Police is that if steps are not taken to consider the running of these premises they will continue to be used in an inappropriate manner which undermines the licensing objectives. It is quite evident from the initial investigation that the licensing objectives have been undermined.

I am conscious of the guidance under the 2003 licensing act on the use of "Expedited Reviews" and given the emphasis that is given to use of this power to tackle serious crime and disorder, my feelings that this process is deemed appropriate are further enforced.

The injured party stated that two unnamed females have been arguing, he has intervened and then been approached by an unnamed male who has slashed him hitting him on the head with a knife, causing blood to run down his face, over his eye and further lacerating his chest causing a wound of approximately 15-20 cms in length and 5-6 cms deep. The injured party was then taken to New Cross Hospital whereby he was treated for his injuries. Staff at New Cross contacted West Midlands Police to report the injuries and officers attended to ascertain the facts of the incident. This is the third incident in 12 months at this premises since opening.

There have been so many attempts by West Midlands Police to work with staff at the venue, liaising with DPS' and PLH's, conversing with solicitors on behalf of the premises, all to no avail. The venue opened around 21st September 2018 and it was observed that no searches were being conducted by the security firm, who were later sacked by the premises.

On the 29th September 2018 there was an incident outside the venue, involving patrons from within the premises, gang nominals and multiple stabbings occurred. This alone could have been enough for WMP to have brought the premises before the Committee in an expedited review as the incident was serious crime and disorder. WMP felt that as a new venue, we could mediate with the DPS/PLH with a view to ensuring that the incident was isolated and that there were the right policies and procedures put into place by the premises. WMP arranged a meeting with the DPS and later attended the venue immediately following the event to discuss licence conditions. It was discussed that the licence would need to be varied and more conditions implemented. The premises had approached a solicitor to act on their behalf and apply for the variation. WMP conversed with said solicitor and a number of conditions were agreed between WMP and the solicitor. This was never progressed due to the solicitor being unable to contact the premise licence holder. WMP continued to communicate with the PLH to address this matter and to date the minor variations have not been applied for.

There was a further incident in December 2018 whereby known gang members attempted to rush the door.

On 5th October 2019 a stabbing occurred at the venue, the third incident, as detailed above. It is the belief of WMP that even if the requested conditions had been applied to the licence via a minor variation this incident would still have happened.

We can justify this comment from the email correspondence received dated 29th September 2019 whereby has stated 'We have a more strict search policy than any other club or bar in town' and 'We have continued with only using plastic glasses after advice from yourselves for the event back last year' and 'We follow any requests that have been required of us like a required amount of security guards. Bottles to booths only. Plastic cups/no glass etc. We have never had any issues.'

These comments are untrue.

- If the strict search policy of patrons going into the venue had been conducted a knife/bladed article would not have been inside the venue, therefore this incident would not have happened.
- Empty glasses were strewn in booths on the sides and on the floor and on the bar when WMP attended on 8th October.
- There have been previous issues at the premises, as detailed above. All of the incidents have involved known gang members from Wolverhampton and Birmingham.

The below claims were made in the same email:

- -Every night were open we have a operating airport style knife arch
- -A guard at the door has a body cam running constantly. Not just during incidents!
- -We have hand held metal detector wands
- -A female guard to search bodies and bags of females
- -We upgrade security for any busy nights or events yourselves think are high risk, to any required numbers.

WMP attended the premises on 8th October to view CCTV and within the premises saw a number of glasses that were dirty, clearly used around the club and on the bar. A broken wine glass was seen on the floor of one of the booths, which was pointed out. was clearly annoyed at this and a number of other issues, such as the clear breach of policies that should have been adhered to. These included the dress code, as people were seen wearing t-shirts, trainers, man bags and the failure to close the venue on time A lack of camera coverage within the club was discussed and on viewing CCTV WMP believe that the incident occurred down by the DJ booth, whereby WMP were told that the cameras in that part were not working. No reason could be given as to why or how long this camera had not been working.

It is the opinion of West Midlands Police that this incident should have been avoided. The venue claimed they had implemented a strict search policy, searching of all persons entering and re-entering, yet a knife was still

permitted into the venue which resulted in a member of the public receiving injuries. This incident was not reported by the venue, with one of the PLH's seen dealing with the group of males who would have been aware of the injury or at least the blood. It is West Midlands Police position that the venue have failed to uphold the licensing objective of Preventing Crime and Disorder.


Serious crime is defined by reference to section 81 of the Regulation of Investigatory Powers Act 2000. In summary, it means:

- Conduct that amounts to one or more criminal offences and involves the use of violence results in substantial financial gain or is conduct by a large number of persons in pursuit of a common purpose.

Serious Disorder is not defined in legislation, and so bears its ordinary English meeting.

Application for a review of a premises licence under Licensing Act 2003 Banjul, 30 Queen Street, City Centre, Wolverhampton, WV1 3JW

I write on behalf of the Licensing Authority as a Responsible Authority. I write in support of the above review application made by Chief Constable of West Midlands Police. Representations are made against Crime and Disorder and Public Safety licensing objectives and the failure of the current management of the premises to promote these objectives.

The premises licence holder's, DGW Entertainment Limited and the management of the premises have not demonstrated they are operating in accordance with their premises licence and therefore are not promoting the licensing objectives of Crime and Disorder and Public Safety.

On 11 October 2019, West Midlands Police submitted an expedited review application due to an event taking place at the premises which resulted in a member of the public receiving a stab wound.

On 15 October 2019, the Statutory Licensing Sub-Committee determined interim steps were necessary and resolved to suspended the premises licence pending the full review hearing.

The Licensing Authority has great concern over the management of the premises as from the evidence provided by the West Midlands Police, it is apparent that serious crime and has occurred at the premises.

If Councillors are satisfied that illegal activities have taken place at the premises and are in breach of promoting the licensing objectives, the Licensing Authority would request the Statutory Licensing Sub-Committee ensure these issues are addressed by considering removal of the current management together with the modification of the current premises licence in accordance with section 52 of the Licensing Act 2003 and guidance issued by the secretary of state under 182 of the Act together with City of Wolverhampton Councils Statement of Licensing Policy.

Councillors may conclude from the evidence given within the review application and at the hearing in order to promote the licensing objectives it is not a suitable option to remove the current management of the premises and that there is no alternative but to revoke the premises licence.

The Licensing Authority fully supports the review application brought by West Midlands Police and concludes the above issues should be resolved in order to promote the licensing objectives of Crime and Disorder and Public Safety.

I shall be in attendance at the hearing should councillors have any questions or require any further assistance.
