1.0 Purpose

1.1 To submit for consideration by the Statutory Licensing Sub-Committee an application for a variation of a Premises Licence

2.0 Background

- 2.1 An application was received on 26 February 2020 from Roma Wines Ltd, the Premises Licence Holder in respect of Roma Wines, 55 Pendeford Avenue, Wolverhampton, WV6 9EH. A copy of the application is attached at Appendix 1.
- 2.2 It is the understanding of the Licensing Authority, that the application to vary this premises licence has been properly made. The statutory requirement to give notice of the application has also been complied with.
- 2.3 The premises are in Tettenhall Regis ward and a location plan is attached at Appendix 2
- 2.4 The application is to extend hours for sale of alcohol off the premises. A copy of the current premises licence is attached at Appendix 3.

Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b,c,d,e)

List here steps you will take to promote all four licensing objectives together.

This is a family run business where everyone has read and understood the course handbook for the Award for Personal Licence Holders and the Licensing Act 2003. There are normally two to three people at work at the shop to ensure there is security by preventing crime and disorder and upholding public safety.

b) The prevention of crime and disorder

There is an alarm installed at the premises which protects it when closed. CCTV is installed inside and outside the premises. All internal areas accessible to the public are covered by the cameras as well as areas immediately outside the premises. The recordings are in real time with the correct date and time. Recordings can be downloaded and uploaded to an external hard drive when requested.

The external lighting also assists in deterring crime as there are floodlights in the front, side and rear of the premises. However these do not impact the neighbours - the shop is located in a row of shops, off the road thus not having a large impact upon neighbours.

The alcohol has been carefully positioned so that is prevents thefts from occurring. The more expensive alcohol is either behind the counter or on the top shelf, near the ceiling.

c) Public safety

The shop is extremely well lit inside which has an impact on the alertness of customers. The floodlights are always on when the shop is open (without having an impact upon neighbours as explained above) so this makes visibility clearer for customers. This also ensures their and our safety. Moreover there is calmer and softer music in the background in the evening when it gets closer to the closing time.

d) The prevention of public nuisance

The music played on the premises is as background music only so there are no issues of noise management in that respect. The meaning of background music is that it must be easy to hear what the customer is saying and easy for them to hear us. The shop door is always closed too so this prevents any noise breakouts - there are no windows on the premises otherwise they would have been closed too. The door that is accessible to the public is self-closing.

Towards the evening, there is more mellow background music playing. There is also no noise disturbances due to waste disposal as this occurs on a weekday during normal working hours, by Wolverhampton Council. There are no deliveries to the premises so this will not have an impact upon noise management.

e) The protection of children from harm

Children are only admitted if they are accompanied by an adult. There is a strict no ID - no sale policy as well as the Challenge 25 scheme. NOTES ON REGULATED ENTERTAINMENT

In terms of specific **regulated entertainments** please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.

 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;





I write on behalf of the Licensing Authority as a responsible authority to submit formal representations under all 4 licensing objectives; Prevention of Crime and Disorder, Prevention of Public Nuisance, Protection of Children from Harm and Public Safety.

A noise complaint was recently submitted to the licensing and compliance team regarding the above premises. Upon a licensing compliance officer attending the premises it was established the premises were trading outside of their permitted licensable hours. The premises licence holder was provided advice by the team on this occasion.

This raises concerns for the Licensing Authority as to the applicants understanding of the legislation surrounding the supply of alcohol.

The application has requested to extend the sale/supply of alcohol off the premises, Monday to Thursday 08:00 - 00:00, Friday & Saturday 08:00 - 01:00, Sunday 10:00 - 00:00 this raises concern for the Licensing Authority as the requested hours seem excessive for the residential location of the premises.

As a result of the above there is insufficient information within the operating schedule to show how the applicant/DPS will promote all four licensing objectives considering the previous history of the premises and its location.

I would like to express my concern on behalf of my parents who live in the residential block above these shops. Recent months have seen the shop staying open a considerable time above what is the agreed closing times. Customers attend and use the shop until the early hours of the morning. There has been a regular pattern of closing at 12am. 12.30am and 1am.

The noise that comes from this is extremely disturbing and is detrimental to my parents health. Customers will pull up outside, leaving radios and engines running, slamming car doors and speeding off down the road which wakes them repeatedly each night.

It is already unbearable for them as they are not in great health.

I am greatly concerned that what is already an unbearable situation has the potential to get worse if these hours are extended.

Bedrooms are situated at the front of the shops, Currently they should close at 11pm, as I have already said, they are closing at 12, 12:30 and 1am. The noise disturbance of the shutters closing at the front adds to the disturbance in the early hours of the morning. Should hours be extended to 1am it is likely that this would be further extended to 2am which would simulate the current situation.

I would ask that this is reconsidered to avoid further nuisance and out of respect for what is a residential area.
