#### 1.0 Purpose

1.1 To submit for consideration by the Statutory Licensing Sub-Committee an application for a variation of a premises licence.

#### 2.0 Background

- 2.1 An application was received on 19 October 2021 from Whitbread Group plc for a variation of a premises licence in respect of The Bluebrick, Broad Gauge Way, Wolverhampton, WV10 0BA. A copy of the application is attached at Appendix 1.
- 2.2 The application is to extend the licensable area and remove premises licence conditions.
- 2.3 The premises are situated in the Heath Town ward and a location plan is attached at Appendix 2.
- 2.4 A copy of the current premises licence is attached at Appendix 3.
- 2.5 It is the understanding of the licensing Authority that the application for the premises licence has been properly made. The statutory requirements to give notice of the application has also been complied with.
- 2.6 All Responsible Authorities have been consulted on this application.
- 2.7 Relevant representations have been received from the Licensing Authority. A copy of the representation can be found at Appendix 4.
- 2.8 The Licensing Authority has proposed mediation with the applicant's solicitor; however, mediation has been unsuccessful. The proposed mediation document can be found at Appendix 5.

#### 3.0 Financial implications

3.1 There are no direct financial implications associated with the recommendations in this report. The fee for this application is £315 and is non-refundable. The fees and charges in relation to the Licensing Act 2003 are set by the Secretary of State. This was noted by the Statutory of Licensing Committee on 20 January 2021 [SB/05012021/W]

#### 4.0 Legal implications

- 4.1 Part 4(1) of the Licensing Act 2003 states that a Licensing Authority must carry out its functions under the Act with a view to promoting the Licensing Objectives, namely:
  - (a) The prevention of crime and disorder
  - (b) Public safety
  - (c) The prevention of public nuisance
  - (d) The protection of children from harm

- 4.2 The general duties imposed on Licensing Authorities means proper consideration must be given to the licensing objectives when determining a premises licence variation application.
  - Section 35 of the Licensing Act 2003 provides the Licensing Authority with the power to vary a licence, subject to conditions, where appropriate
- 4.3 In addition, regard shall be had to guidance issued by the Secretary of State under Section 182 of the Licensing Act 2003 and Wolverhampton City Council's Licensing Policy Statement [SH/03122021/A].

#### 5.0 Equalities implications

- 5.1 This report has human rights implications for both the premises licence holder and the residents from the local neighbourhood. Any of the steps outlined in Section 4 of this report may have financial implications for a licensee's business and livelihood and/or may have impact on the day to day lives of residents living in close proximity to the premises.
- 5.2 Article 8(i) of the European Convention of Human Rights provides that everyone has the right to respect for his/her private family life and his/her home (which includes business premises). This right may be interfered with by the Council on a number of grounds including the protection of rights and freedoms of others. The First Protocol Article 1 also provides that every person is entitled to peaceful enjoyment of his possessions and shall not be deprived of his possessions except in the public interest and conditions provided for by law. Members must accordingly make a decision which is proportionate to the hearing and endeavour to find a balance between the rights of the applicant, residents and the community as a whole

To increase the outdoor licensed area to include a block paving area on a section of the slip road controlled by the premises, as detailed on the plan attached to this application. For completeness, the plan attached to this application is to include the entrance way and terraced area, which is currently licensed dating back to 24th April 2007, as most recently confirmed by the Licensing Authority on the 3rd September 2021. The plan attached to this application is plan number 1513\_16, which shows the proposed external area edged in red. For the avoidance of doubt, this application does not intend to alter the existing internal licensed area, which remain as currently licensed. As the application is to increase the licensed area of the premises only, there is no increase in the operating hours of any licensable activity and therefore Part 4 has not been completed. 2. The Applicant also seeks to remove the following conditions from the Premises Licence as they are outdated and/or superseded by relevant legislation. The relevant conditions to be removed are as follows; **Public Safety** "All building works comply with current Building Regulations". "Confirmation must be provided that both the fire alarm and emergency lighting systems comply with current British Standards" "The Fire Authority must be advised of all charges (SIC) to the approved plan (plan at application) which may take place during construction" "The premises will not open to public or quests until such time the Fire Authority are satisfied that all issues affecting Public Safety have been addressed" Protection of Children from Harm "The restrictions set out in the Licensing Act 2003 will apply." No new steps have been identified in relation to the four licensing objectives save as below.

b) The prevention of crime and disorder

An electronic or written incidents log will be maintained at the premises with a record of all incidents of crime and disorder reported to or by the premises; all ejections of patrons; any complaints received; seizures of drugs, offensive weapons, fraudulent ID or other items; any faults in the CCTV system; any visit by a relevant authority or emergency service. The incidents log will be produced to an officer of a responsible authority upon request. Where a crime is believed to have been committed, the incident will be reported to the West Midlands Police. The incidents log will be kept for at least 12 months and will be produced to an officer of a responsible authority upon request.

#### c) Public safety

The designated premises supervisor shall ensure that tables are cleared of all bottles and glasses on a regular basis during trading hours to avoid an accumulation of glassware.

The premises licence holder shall ensure that at all times when the public are present there is at least one competent and fully trained person able to administer first aid, that an adequate and appropriate supply of first aid equipment and materials is available on the premises, and that adequate records are maintained in relation to the supply of any first aid treatment.

d) The prevention of public nuisance

No further risks have been identified which need to be addressed

e) The protection of children from harm

The premises shall operate a proof of age scheme and will require photographic identification from any person who appears to be under the age of 18 years. (The below conditions is an extension to this already existing condition regarding age verification)

Proof of age will only comprise a passport, photo card driving licence, an EU/EEA national ID card or a card bearing the PASS hologram. When age-restricted goods are delivered to a customer's hotel room, the person who takes receipt of the goods must be subject to age verification. Where age verification is required, an original valid photographic identity document must be provided. Delivery staff shall be over 18 years of age. Where a delivery person has concerns further to child protection at any room to which alcohol has been delivered, these concerns shall be made known to the premises licence holder and duty manager with a minimum of delay, whereupon the premises licence holder shall report the matter to Wolverhampton's Emergency Duty Team.

An electronic or written refusals log will be maintained at the premises with a record of all refusals of admission or service, including the sale of alcohol. The refusals log will include the basis of a refusal; the person making the decision to refuse; the date and time of refusal. The refusals log will be kept for at least 12 months and will be produced to an officer of a respectively upon request.





If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.

- You do not have to pay a fee if the only purpose of the variation for which you are applying is to avoid becoming liable for the late night levy

No customers apparently carrying open bottles upon entry shall be admitted to the premises at any times the premises are open to the public. Alcoholic and other drinks may not be removed from the premises in open containers save for the consumption in any external area provided for that purpose.

Staff will receive training on matters concerning underage sales, drugs policies and operating procedures.

There shall be a zero tolerance policy in relation to drugs at the premises and there shall be regular checks by management to prevent the use of drugs by patrons. Drugs seized shall be stored securely and handed to the police.

The premises shall operate a proof of age scheme and will require photographic identification from any person who appears to be under the age of 18 years.

The management of the premises will liaise with police on issues of local concern or disorder.

The premises will support the local pub watch scheme where such scheme is in operation.

CCTV will be installed with recording facilities such recordings shall be retained for a period of 31 days and made available within a reasonable time upon request by the police, such as to cover the main entrance to the premises.

There shall be no drinks promotions at the premises which are inconsistent with the need to promote responsible drinking.

#### **Public Safety**

No further risks have been identified which need to be addressed, save as below:

To comply with the reasonable requirements of the fire officer from time to time.

The premises will have adequate safety and fire fighting equipment and such equipment will be maintained in good operational order.

Staff will be trained on matters of safety, evacuation and use of emergency equipment as required.

Spillages and breakages will be removed as soon as possible to reduce the risk to patrons and staff.

Toughened glasses will be used in the premises where appropriate.

Fire exits and means of escape shall be kept clear and in good operational condition.

The premises will not open to public or guests until such time the Fire Authority are satisfied that all issues affecting public safety have been addressed

All certification relating to furniture and furnishings will be available to the Fire Authority prior to the final inspection.

All building works comply with current Building Regulations.

Confirmation must be provided that both the fire alarm and emergency lighting systems comply with current British Standards

The Fire Authority must be advised of all charges to the approved plan (plan at application) which may take place during construction.

An RCD (Residual Circuit Device)to be fitted to the main distribution board or the individual socket where regulated entertainment takes place.

#### Amended in variation 16/11/2010

A maximum capacity of 210 persons is permitted for the internal licensed area during times of regulated entertainment.

#### **Prevention of Public Nuisance**

No further risks have been identified which need to be addressed, save as below.

Where appropriate, prominent, clear and legible notices shall be displayed at all exits requesting the public respect the needs of local residents and to leave the premises area quietly.

Patrons will be encouraged by staff to leave quietly and respect the interests of the occupiers of any nearby noise sensitive premises.

Where appropriate the licensee or a suitable staff member will monitor patrons leaving at the closing time.
