## 5 Review of Fees and Charges for Hackney Carriage and Private Hire Licensing functions for 2023-2024

Chris Howell, Commercial Regulation Manager, presented the report: Review of Fees and Charges for Hackney Carriage and Private Hire Licensing functions for 2023-2024. The report outlined the proposed fees and charges relating to Hackney Carriages, Private Hire vehicles, drivers and operators' licences, and related licensing functions, from 1 April 2023.

The Commercial Regulation Manager provided an overview of the proposed changes and explained the rationale for these changes. It was noted that due to a large increase in demand for private hire driver licences, fees would be significantly reduced in order to reduce the surplus of the licensing reserve.

Members of the Committee welcomed the reduction in fees and thanked officers for their efforts in achieving this.

Councillor Muston moved the recommendations within the report and Councillor Potter seconded the recommendations.

#### Resolved:

That Members of the Regulatory Committee:

- 1. Approved the proposed fees and charges with effect from 1 April 2023.
- 2. Approved the abolition of one-year licences for private hire vehicles aged over ten years, to deliver administrative savings.
- 3. Noted that the reduction in fees was expected to reduce the surplus of the licensing reserve.
- 4. Noted that six-month licences for Hackney Carriages would be withdrawn.

The Chair closed the final meeting of the Municipal Year by thanking Members and officers for their support throughout the previous twelve months. The Committee reciprocated it's thanks to the Chair.

The Regulatory Committee is recommended to:

1. Approve the proposed Health and Safety Statutory Plan 2023 - 2024

#### 1.0 Purpose

- 1.1 To inform the Regulatory Committee of the legal requirement to produce a Health & Safety Statutory Plan.
- 1.2 To seek Regulatory Committee approval for the 2023 2024 Health and Safety Statutory Plan. The proposed plan is attached at appendix 1.

#### 2.0 Background

- 2.1 The Council is responsible for protecting the health, safety, and welfare of people at work in Wolverhampton and to safeguard others, principally members of the public, who may be exposed to risks from the way that work is carried out; either in Wolverhampton, or by employers whose managerial control is based in Wolverhampton. This responsibility is shared with the Health and Safety Executive and the Care Quality Commission. The Health and Safety (Enforcing Authority) Regulations 1998 determine who is responsible for whom at what premises.
- 2.2 Traditionally Local Authorities would have delivered their responsibilities through thorough proactive inspection programmes as well as reacting to reports of near misses, accidents and complaints of poor health and safety standards. Over recent years following changes in guidance, 'LAC67/2 Setting Local Authority Priorities and Targeting Interventions', from the HSE, proactive inspection has been reduced to only the highest risk businesses. This risk is assessed on; confidence in management, safety performance, health performance and welfare needs compliance. Other businesses would only be contacted proactively via national planning priorities, to raise awareness by providing advice and education based on the HSE's most current regulatory intelligence used to help local authorities target their activity in areas that deliver key elements of the wider GB strategy for the health and safety regulatory system. Businesses could still receive reactive inspection following reports of near misses, accidents and complaints of poor health and safety standards.
- 2.3 The HSE provides the list of 'Activities/ Sectors for proactive inspection by Local Authorities', only those sectors listed can be inspected and the inspection is limited to the high-risk activities detailed.
- 2.4 Furthermore, under Section 108 of the Deregulation Act 2015 the Local Authority is required to consider the promotion of economic growth when exercising regulatory functions. Regulatory action is only taken when needed and any action taken must be proportionate.
- 2.5 The Health and Safety Statutory Plan is a requirement under the 'National Local Authority Enforcement Code for Health and Safety at Work'. This code is mandatory guidance issued by the Health and Safety Executive under Section 18 of the Health and Safety at

Work Etc. Act 1974. The Health and Safety Statutory Plan is one of two statutory service plans implemented by Commercial Regulation Services. The Health and Safety Statutory Plan is a commitment to delivering the service including the resources that will be allocated and creates a standard against which the service can be audited.

- 2.6 The Health and Safety Statutory Plan for 2023 2024 details the resources allocated, priority areas of activity and a reduced number of proactive inspections.
- 2.7 The plan also highlights the key achievements achieved for 2022 2023, which included: a Stress and Mental Health awareness campaign, to prevent and support good mental health at work; advice to businesses on the safe use of inflatables and other amusement devices; written and verbal advice to businesses on outdoor electrical safety ahead of the Queen's Jubilee and Commonwealth Games. Proactive inspections of larger warehouse distribution centres and wholesale sites were also undertaken based on intelligence concerning workplace transport, and over 143 requests for service were responded to. A total of six improvement notices, seventeen prohibition notices, and one simple caution were issued during this time.

#### 3.0 Progress

- 3.1 The Health and Safety Statutory Plan is a Statutory document and is required to be produced annually. The plan sets out the priorities for the Service and is available for members of the public to view so that they are aware of what the authority is doing to safequard people.
- 3.2 It is requested that the Regulatory Committee approve the 2023 2024 Health and Safety Statutory Plan.

### 4.0 Financial implications

- 4.1 The overall resource provision required to deliver the requirements of the plan fall within the Resident Services portfolio.
- 4.2 The approved budget for the Environmental Health Service 2023 2024 is £682,900, which includes the provision of the Health and Safety service. It should be recognised that a wide range of other non-health and safety related services are delivered within this budgetary provision. The level of resource available for the provision of health and safety activities covered by the statutory plan is currently in the region of £84,800. This is monitored through the Council's routine quarterly revenue monitoring process.

### 5.0 Legal implications

5.1 It is a legal requirement to produce a Health and Safety Statutory Plan.

- 5.2 Health and safety enforcement is a function which must not be the responsibility of an authority's executive. Functions under any of the "relevant statutory provisions" within the meaning of Part 1 of the Health and Safety at Work etc Act 1974, fall to the Licensing Committee to approve.
- 5.3 Under Section 18 of the Health and Safety at Work etc Act 1974 the Authority is required to make "adequate arrangements" for the enforcement of health and safety within the City. The production of an annual service plan is a mandatory requirement of the guidance to this obligation. The endorsement of the plan is the responsibility of the Licensing Committee.
- 5.4 Failure to produce or deliver the statutory plan may result in measures being taken against the authority.

## 6.0 Equalities implications

- 6.1 The Health and Safety Statutory Plan aligns the support and enforcement activities of the Commercial Regulation Service with HSE guidance, all activity is intelligence/ risk based and activity is only undertaken where necessary.
- 6.2 All regulatory activity is undertaken in accordance with the Black Country Regulators Operating Framework, previously approved by Cabinet.
- 6.3 Any prosecutions are taken in accordance with the Home Office Code for Crown Prosecutors, which includes an evidential and public interest test. The evidential test is undertaken by Legal Services and final approval for prosecution is via the Head of Service.

#### 7.0 All other Implications

7.1 Implementation of the Health and Safety Plan and the subsequent inspection of businesses within the City helps to ensure that businesses comply with the law and protect the health, safety and welfare of their employees, and any other individual who may be exposed to risks from the way that work is carried out. All work undertaken by the Service is aimed at securing the health and wellbeing of residents and visitors to the City.

## Introduction


This is the City of Wolverhampton Council's Health and Safety Service Plan, dedicated to the health and safety enforcement function. It covers all elements of responsibilities relating to premises and functions falling within this Council's remit for health and safety enforcement as encompassed within the Health and Safety (Enforcing Authority) Regulations 1998.

The Health and Safety Service Plan is an expression of this Councils commitment to Health and Safety Enforcement and is a requirement of the Health and Safety Executive (HSE) as the body that monitors, audits, and broadly sets Councils' activities on health and safety enforcement. It also plays a vital role towards contributing to the Council Plan, and the Councils vision for 2030. The format and content of this service plan incorporates mandatory guidance issued by the HSE under Section 18 of the Health and Safety at Work etc. Act 1974. This is the standard which, local authorities must reach in relation to their priorities.

Health and Safety has undergone dramatic change over recent years. Through its actions via LA Code of Practice 67/2 (Revision 12) (LAC 67/2) and modifications to the Reporting of Injuries, Diseases and Dangerous Occurrences Regulations (RIDDOR). Health and Safety enforcement is confined to distinct nationally applied high-risk areas or local intelligence-based enforcement. Consequently, the nation-wide number of inspections has fallen dramatically to around 5% of what they were. There is no longer a legal requirement to register premises for health and safety enforcement and local authorities must rely on local 'intelligence information' to root out poor practices. It is against this backdrop that local authorities must now perform. Local authorities are able to respond to matters of evident concern and have done so where there is a serious risk of personal injury.

For 2023-2024 The City of Wolverhampton Council health and safety team will follow the national LA Code of Practice – LAC 67/2. This includes national priorities such as work-related stress and mental health and electricity in hospitality settings, amongst others. The Service will continue to investigate workplace accidents in keeping with national selection guidance that identifies which accidents and incidents are worthy of investigation and those which are not.

During the financial year for 2022 – 2023, 315 leaflets were emailed and or distributed on site to commercial catering premises regarding the importance of ensuring that any gas installations and appliances are maintained in a safe condition. 586 premises were written to regarding the safe use of bouncy castles and other inflatable amusement devices, ahead of the Queen's Jubilee and Commonwealth Games, and 586 leaflets were distributed to Hospitality and Entertainment Settings regarding electrical safety, including the use of outdoor areas, and duties to maintain equipment in a safe condition.

Following local intelligence, a leaflet was produced and distributed via email to 287 Nail Bars and Beauty Salons providing practical advice on how to avoid the spread of infection in a salon, undertaking a risk assessment, and included a checklist of things to consider.

A Stress and Mental Health awareness campaign was launched, to prevent and support good mental health at work. A news letter, which included a leaflet was sent to over 5,000 businesses and their employees, providing access to a free on-line webinar, including advice on risk assessments, tools and practical guidance.

The health and safety team continue to undertake and fulfil the roles and responsibilities of the Council in undertaking statutory duties at qualifying sports grounds across the city, working in conjunction with partner agencies, to ensure that reasonable steps are taken to ensure that all people are protected from physical harm or injury.

## 1.0 Aims and Objectives

- 1.1 To protect the health, safety, and welfare of people at work in Wolverhampton and to safeguard others, principally members of the public, who may be exposed to risks from the way that work is carried out. The Environmental Health Service will follow the National Local Authority Enforcement Code. This code defines 'adequate arrangements for enforcement' of health and safety legislation at premises, which is requirement under section 18 of the Health and Safety at Work Act 1974.
- 1.2 The service will prioritise their work based on the national priorities set by the HSE, with the key objective to focus on the safety of the workforce and protect them from work related ill health.
- 1.3 Proactive inspection will only be used for high risk premises or where intelligence suggests that risks are not being effectively managed.

- 1.4 Staff will follow the incident selection criteria set by the HSE to determine whether to investigate accidents, incidents, and cases of ill health.
- 1.5 Education plays an important part in improving health and safety standards where local intelligence identifies sector issues we will consider undertaking a proactive awareness campaign subject to resources.
- **1.6** Staff will support the Primary Authority Principle.
- 1.7 Staff will refer to the Black Country Local Authorities Enforcement policy and the Enforcement Management Model issued by the HSE when undertaking health and safety enforcement.



## 2.0 Scope of the Health and Safety Service

- 2.1 The role of this service is to support, encourage and advise and where necessary to hold to account businesses to ensure that they manage their occupational health and safety risks. This will be through:
  - Provision of advice, investigating complaints and accidents and inspection only where specifically identified.
  - Acting as responsible authority in relation to the Licensing Act 2003 applications and as consultee in relation to relevant planning and building control applications.
  - Acting as the responsible authority on behalf of the Council in relation to statutory duties as mentioned in the Safety of Sports Grounds Act 1975 (as amended) and the Fire Safety and Safety at Places of Sport Act 1987 at each of our four qualifying sports grounds.
  - Commenting on proposed health and safety legislation, codes of practice, guidance, and other official documents as necessary and as requested.
  - Promoting and enforcing as necessary the provisions contained in the Health Act 2006, relating to smoke free workplaces and vehicles.
  - Identification of cosmetic body piercing activities (acupuncture, tattooing, semipermanent skin colouring, cosmetic piercing, and electrolysis) requiring registration and prepare them for the issue of registration.

- 2.2 The team is available from 9:00 am 5pm. Monday to Thursday and 9:00 am 4.30 pm on Friday. Out of Hours interventions are carried out where required.
- 2.3 Informal arrangements are in place for contacting senior officers regarding matters arising outside of normal working hours e.g., accidents and incidents.



## 3.0 Service Delivery

- 3.1 The Health and Safety Executive has published a range of guidance for LA's to create a targeted regulatory programme.
- 3.2 In May 2013 the HSE published the National Local Authority Enforcement Code (The Code). The Code provides Local Authorities (LA) with guidance on intervention and enforcement programmes so that LA regulators take a consistent and proportionate approach to their regulatory interventions. It also sets out the Government expectations of a risk-based approach to targeting health and safety interventions and enforcement.
- 3.3 The Code provides LA's with a principles-based framework that focuses regulatory resources on the basis of risk via a range of different regulatory techniques and interventions. Advice to Local Authorities on targeting interventions is contained in Local Authority Circular 67/2 (rev.12) which sets out a list of national priorities and provides guidance on setting local priorities.



## 4.0 National Priority Projects

- 4.1 For 2023 2024 the HSE have set a number of topics which are deemed to be of national priority. The City of Wolverhampton Council will conduct the following projects that have been identified as being a national priority: -
- 4.2 Raising awareness of the work related stress and mental health campaign 'Working Minds' with businesses

  The service will continue to raise awareness of workplace stress across all small and medium business enterprises, and will work with stakeholders to keep people better informed. Awareness will target employers and their workers to ensure that they have the necessary tools to prevent work related stress and help to support good metal health at work.
- 4.3 Electricity safety in hospitality settings In 2018, a seven-year-old boy tragically lost his life after he touched 'defective' lighting and was electrocuted in a pub beer garden.

Proactive inspections will be undertaken to pubs, bars, restaurants and cafes urging duty holders to ensure that outdoor electrical equipment, such as lights and heaters are especially designed for outdoor use, are installed by a competent person, and maintained in a safe condition. Officers will undertake checks with businesses during routine food safety visits.

4.4 Inflatable amusement devices

There have been a number of serious incidents where inflatable amusement devices have collapsed or blown away in windy conditions.

Advisory safety information will be issued to premises who are likely to use devices or install these devices, such as hospitality venues and community centres around the Coronation of King Charles III. Highlighting the importance of safe installation and use; suitable arrangements for measuring weather conditions; written documentation from a competent inspection body; and annual inspection by a competent person.

## 4.5 Gas safety in commercial catering premises

Officers will raise awareness with local duty holders of the importance of gas safety and risks of exposure to carbon monoxide in commercial kitchens from badly installed or faulty appliances; poor ventilation resulting in lack of make-up air to support combustion; and/or inadequate extraction systems.

Officers will check with businesses that gas has been properly installed and is maintained and inspected by a competent gas safe registered engineer during routine food hygiene inspections.

4.6 Welfare provision for delivery drivers
Raise awareness with hospitality venues
and warehouses that receive or send
regular deliveries that the law requires
welfare provisions to be made available,
such as access to toilet, hand washing and
rest facilities if the premises has been
made available to them as a place of work.

Officers will check and advise as necessary during routine food hygiene, and pro-active health and safety inspections.

## 5.0 Proactive Inspection

- 5.1 Proactive inspections will be undertaken where local intelligence suggests the risks identified in Annex B of the LAC 67/2 health and safety guidance are not being controlled.
- 5.2 Since 1 April 2022, the service has undertaken intelligence led inspections concerning workplace transport at thirteen of our larger warehouse distribution centres and wholesale sites. This work has been successful, and will continue throughout 2023 2024, on both an intelligence led basis and as part of a pro-active inspection programme.

## 6.0 Sports Ground Safety

- 6.1 Under the provisions of the Safety of Sports Grounds Act 1975 local authorities are responsible for issuing and enforcing safety certificates for designated grounds and regulated stands.
- 6.2 A safety certificate will set the permitted capacity for the sports ground together with the detailed terms and conditions with which the ground management must comply in order to operate the sports ground at its permitted capacity.
- **8.3** The authority has four certified grounds:
  - Molineux Stadium home to Wolverhampton Wanderers FC
  - Wolverhampton Race Course
  - Aldersley Stadium
  - Monmore Green Stadium
- 6.4 The certified grounds are subject to inspection to ensure that they are operating in accordance with the conditions on the safety certificate. The frequency of inspection varies for different sites and is determined by risk.

- 6.5 Molineux Stadium is a designated ground so the certificate applies to the whole ground. This has an annual walkabout inspection and a minimum of 4 during performance inspections, with 3 SAG's in October/January/May.
- 6.6 The Regulated stand at Wolverhampton Racecourse, which has a capacity >2000 spectators has an inspection annually, whereas Aldersley Stadium, and Monmore Green Stadium have one every two years, with a SAG annually or bi-annually accordingly.
- 6.7 Information obtained from inspections of Molineux Stadium is required to be fed back to the Sports Ground Safety Authority (SGSA), and they carry out their own independent annual audit to ensure that as a Local Authority we are performing our role satisfactory.

- 6.8 Since 1 April 2021 significant work has been undertaken at the Wolverhampton Wanderers Football Club, including continued oversight of flame and pyrotechnic effects that are used during match days, renewal of certificates, oversight of the rebuild of the Graham Hughes stand, liaison with WMFS regarding the club's fire risk assessment, oversight of the application to have licensed standing areas as well as regular document reviews. Monitoring has also been undertaken to ensure the licensed standing areas do not lead to standing elsewhere in the ground.
- 6.9 Our Sports Grounds venues are popular locations for large scale concerts, attracting high volume crowds. We ensure that reasonable steps are taken to protect attendees from physical harm or injury.




## 7.0 Health and Safety Complaints

- 7.1 Since 1 April 2022, the service has responded to over 143 requests for service in relation to health and safety. This can range from enquiries about health and safety law e.g., employers/proprietors' duties, through to complaints and "whistle blowers" detailing serious workplace conditions or reports of dangerous practices.
- 7.2 All health and safety complaints received, including anonymous complaints are prioritised and investigated in accordance with the good enforcement principle of targeting, transparency, consistency and

- proportionality. Emphasis is placed on those complaints that have the potential to cause most harm to employees or the public via a risk-based approach.
- 7.3 All requests for service are logged on to the back-office system (Uniform) and any action taken in relation to a complaint is logged on this system too.
- 7.4 Any enforcement action during an intervention where the public are affected, and is available to view upon request to encourage local accountability.

## 8.0 Accident Investigations

- 8.1 Since 1 April 2022, the service has received 62 accident investigation reports. The Reporting of Injuries, Diseases, and Dangerous Occurrences Regulations 2013 (RIDDOR), places duties on employers, the self-employed and people in control of work premises to report certain workplace accidents, occupational diseases and specified dangerous occurrences (near misses).
- 8.2 All accident investigations received are prioritised and investigated in accordance with the RIDDOR Regulations, and HSE incident selection criteria.
- 8.3 All RIDDOR reports are logged on to the back-office system (Uniform) including any action taken in relation to the accident.



## 9.0 Enforcement Action


- 9.1 The Health and Safety Service endeavors wherever possible to use informal means to achieve compliance with the law. Where there is evidence of imminent risk, flagrant breaches of the law, or persistent failure to maintain standards, the service will exercise their powers in accordance with its Enforcement Policy, and will follow the general principles of proportionality, consistency, transparency and targeting of resources when applying the law.
- 9.2 Since 1 April 2022, the service has served six improvement notices following matters relating to electrical installations, workplace transport and work at height concerns. Seventeen prohibition notices were served following evidence of imminent risk, including falls from height, unsafe racking, and matters relating to non surgical buttock augmentation injections. One simple caution was also issued for concerns relating to poor management of legionella in a hotel.

## 10.0 Cooling Tower Registration

- 10.1 Many large factories and office blocks have cooling towers and evaporative condensers associated with their air conditioning units. As there is a risk of spreading legionnaires disease from these units all premises where cooling towers and evaporative condensers are situated must register with the Council under The Notification of Cooling Towers and Evaporative Condensers Regulations 1992. There are currently 27 sites with cooling towers registered with the authority.
- 10.2 Registered premises within Wolverhampton which are enforced by the Council for health and safety may be subject to an inspection / intervention visit.

## 11.0 Cosmetic Body Piercing Registration

- 11.1 Under the Local Government (Miscellaneous Provisions) Act 1982, personal and premises registration is required for the activities of Acupuncture, Tattooing, Semi-Permanent Skin Colouring and Cosmetic Body Piercing, and compliance with local adopted Bye Laws.
- 11.2 As there is a risk of cross contamination including blood borne viruses and other skin infections, an inspection is important to review risk assessments, including infection prevention and control procedures.
- 11.3 Since 1 April 2022, the service has reviewed and inspected against 42 applications for the certification of registration to be granted for Cosmetic Body Piercing activities.



## 12.0 Event Safety Advisory Group

- 12.1 The Event Safety Advisory Group is a multiagency Group formed to offer guidance to anyone organising a public event in Wolverhampton. The council will aim to ensure that assistance is consistent and will encourage a minimum standard of safety at all events held throughout the area.
- 12.2 The Group provides an opportunity to implement a co-ordinated process that enables organisers of public events to give notification of a future event and to ensure this information is disseminated across all agencies.
- 12.3 The Group is currently chaired by the Licensing Manager, with the following council departments and other government authorities being represented:
  - Licensing
  - Highways
  - Trading Standards
  - Environmental Health
  - Public Health
  - Building Control
  - Internal Health and Safety
  - West Midlands Police
  - West Midlands Fire Authority
- 12.4 Since 1 April 2022, the Environmental Health Service have reviewed 100 applications via the Event Safety Advisory Group, and provided support on compliance with food, health and safety and noise compliance.

## 13.0 Liaison with other Organisations

- 13.1 The City of Wolverhampton Council are part of the West Midlands Health and Safety Liaison Group (WMHSLG), who work together to produce common policies, practices and procedures to aid consistency. The group also organises regular training programmes for enforcement officers.
- 13.2 The City of Wolverhampton Council are also part of the West Midlands Skin Piercing Liaison Group (WMSPLG), who work together to tackle common problems across the High Street with beauty, tattooing and non-surgical aesthetic treatments. The group produces common policies, practices and procedures to aid consistency.
- 13.3 Officers continue to work with the Chartered Institute of Environmental Health (CIEH), The Institute of Licensing (IoL), and

- The All Party Parliamentary Group (APPG) for Beauty and Wellbeing, to assist with the campaign and implementation of a licensing scheme to regulate non-surgical aesthetic treatments available on the High Street.
- **13.4** As a Council we liaise with other organisations as appropriate such as the Fire Rescue Service and the Police.
- **13.5** The service also advises and liaises with other services within the Council, including Building Control, Planning and Licensing.
- 13.6 Safety Advisory Groups have been set up for certified grounds, their function is to provide specialist advice to the local authority so it can discharge its functions under the Safety of Sports Grounds Act 1975 (1975 Act) and / or Fire Safety and Safety of Places of Sport Act 1987.



## 14.0 Health and Safety Partnerships

- 14.1 The City of Wolverhampton Council are partners with the HSE and the National Association of Steel Service Centres to create the Steel Stockholding Lead Authority Partnership, which has been in existence now for over 20 years. This has created published industry guidance, training and guidance for both industry and officers has been developed through this group.
- 14.2 The Council has three developed Primary Authority Partnership's with Marston's PLC, Little Dessert Shop (Holdings) Ltd and CMC Consultancy. The partnerships primarily focus on health and safety, food hygiene and standards.
- 14.3 Primary authority is a means for businesses to receive assured and tailored advice on (amongst other areas) meeting environmental health and trading standards regulations through a single point of contact.
  - In maintaining our primary authority partnerships, officers from the service will:
  - respond to enquiries from other local authorities about, or concerning, the business or its operations or procedures
  - act on behalf of other local authorities as the primary regulatory link to the business
  - provide advice to the companies on the interpretation of legislation
  - provide assistance to enforcing authorities in the conduct of investigations and encourage the businesses to offer reasonable assistance.

The authority will have regard to the Primary Authority Partnership Scheme and associated official guidance when considering formal legal action.

## 15.0 Resources

#### 15.1 Staffing Allocation

The Environmental Health Service is a multi disciplinary team. There are 17 officers who undertake a range of duties, including health and safety enforcement.

The proportion of an officers time spent undertaking health and safety work will vary throughout the year and is dependent on what incidents are reported to the service. The service manager alongside the team leaders will continually monitor the work the service is doing through out the year and reallocate resources as required.

- 15.2 The approved budget for the Environmental Health Service 2023 2024 is £682, 900, which includes the provision of the Health and Safety service. It should be recognised that a wide range of other non-health and safety related services are delivered within this budgetary provision. The level of resource available for the provision of health and safety activities covered by the statutory plan is currently in the region of £84,800.
- 15.3 Whilst it is the intention of the Service to undertake the work outlined in the service plan this will continue to be subject to the level of resource and the emerging issues, which arise during the year.

## 16.0 Staff Training and Development

- 16.1 Officers individual training needs are identified formally during employee professional conversations, which are held quarterly. In addition, Officers are assigned lead responsibilities to develop a specialism within the commercial sector.
- 16.2 Officers that are members of the Chartered Institute of Environmental Health (CIEH) are required to undergo at least 20 hours of Continuous Professional Development (CPD) per year. The service recognises this need and supports staff in achieving this.
- 16.3 Typical sources of training include day release courses, on the job training and development, in house short courses and cascade training, and external short courses and seminars.

#### Recommendations for decision:

The Regulatory Committee is recommended to:

- Approve the proposed Street Trading Consent Fees as set out in Appendix 1 of the report. If approved, it is proposed that the new fees shall be payable by new applicants immediately. All other changes for existing consent holder shall come into force on 1st April 2024.
- 2. Approve the proposal to offer a staged increase to private land consent fees over a three-year period as outlined in section 4.3 of the report.

#### 1.0 Purpose

1.1 To submit for consideration and approval the proposed street trading consent fees detailed in Figure 1 of Appendix 1.

### 2.0 Background

- 2.1 The Local Government (Miscellaneous Provisions Act) 1982 empowers the Council to charge a levy for the granting or renewal of a street trading consent.
- 2.2 The Constitution delegates authority to Regulatory Committee to approve and vary street trading consent fees.
- 2.3 The City of Wolverhampton Council Street Trading Policy was adopted on 1 April 2023 following Regulatory Committee review and approval on 11 January 2023.
- 2.4 In determining the fees for street trading consents the council may consider several factors including, the cost of processing and regulating the consent; the duration of the consent; the location of the consent and the type of goods, which the consent holder is authorised to trade.
- 2.5 As part of the overall Street Trading review and with the return of the Promotional Spaces to the control of the Council, a thorough review of the existing consent application process was required to ensure the application criteria reflects the new policy and to determine if the existing fee adequately covers officer time to process an application.
- 2.6 In addition, it was determined appropriate to ensure the consent fee accurately reflects the location premium.

#### 3.0 Development of Street Trading Consent Fees.

- 3.1 To determine the fees the application processing tasks have been itemised based on the time required to undertaken them. As a result, application processing tasks have been split into two parts; Part 1: the application processing time and Part 2: the granting of the consent processing time; with a cost allocated to each based on the current officer hourly rate. Officer time costs align to the hourly rates calculations in Appendix 3 Commercial Regulation Cost Recovery Policy 2023 2024, which was approved by Cabinet (Resources) panel 16 November 2022, for adoption, commencing 1 April 2023. The total cost processing an application has been calculated at £632.00.
- 3.2 In addition, and as the fees have not altered in excess of eight years, it was determined appropriate to ensure the consent fee accurately reflects the location premium. For example, an A Type consent in Dudley Street, City Centre benefits from more footfall than other areas of the City, hence why it currently attains the highest fee of all consent types.
- 3.3 A Part 3 cost has therefore been determined, by using the Valuation Office Agency (VOA) business rates for 1 April 2023 as the source for comparing current business

- rates, against the existing street trading consent locations across Wolverhampton as listed in Figure 1, Appendix 1 Proposed Street Trading Consent Fees.
- 3.4 Using Dudley St, City Centre as the baseline (prime) location, the other existing street trading consent locations then have either an increase or decrease calculation applied, against its comparable business rate in the same location.
- 3.5 It is acknowledged that in some cases the standard VOA calculation would increase some existing consent fees exponentially, which poses a risk of making a consent too expensive for existing street traders to continue trading or alienating start-up businesses with a large upfront cost. Discretionary discounts have therefore been applied to selected consent types to encourage trade in the City.
- 3.6 The rationale behind the calculations and key changes to the current street trading consent fees are outlined in Appendix 2 of the report.
- 3.7 It is recognised that some increases are significant, and it is intended that the option for street traders to pay in instalments will continue.

#### 4.0 Private Land Consents

- 4.1 Street Traders must have a consent even if they trade on private land and they are subject to the same application process as street traders who trade on Council owned land.
- 4.2 The current cost of a private land consent is artificially low and does not reflect the cost of administering the application process (£632.00). It is recognised that to increase the current private land consent fee to the proposed application fee would be too considerable for existing traders who also pay rent to trade on private land.
- 4.3 Consequently, it is proposed to offer a staged increase to private land consent fees over a three-year period. With private land traders being charged 50% (£316.00) of the consent fee on the first year, 75% (£474.00) on the second year and 100% (£632.00) on the third year. The staged increase will only apply to existing private land consent holders. All new applicants for private land consents will be charged the full fee of £632.00.
- 4.4 Although the increases for private land consents are significant, an increase to £316 = £6 per week, an increase to £474 = £9 per week and the full fee payable of £632 is only £12 per week.

#### 5.0 Financial implications

5.1 The fees for street trading have been kept at their current level for more than eight years. The Committee have previously agreed reductions and fee-free periods to help traders through, and to recover from the Covid-19 pandemic.

- 5.2 The cost of introducing, administering, and enforcing street trading consents will be recovered through the application fee and processing fee and will be delivered within the budgets for the Street Trading function. This will be monitored as part of the routine quarterly revenue monitoring.
- Officer time costs align to the hourly rates calculations in Appendix 3 Commercial Regulation Cost Recovery Policy 2023 2024, which was approved by Cabinet (Resources) Panel 16 November 2022, for adoption, commencing 1 April 2023.

#### 6.0 Legal implications

- 6.1 The Local Government (Miscellaneous Provisions Act) 1982 empowers the Council to charge a levy for the granting or renewal of a street trading consent.
- 6.2 The Council is under constitutional duty to review its fees and charges at least annually and to maintain a register of such charges.

#### 7.0 Equality Implications

7.1 The Council operates an open and consultative approach to the development of its budget and the general financial position of the Council has, once again, been the subject of detailed public consultation. The changes to consent fees outlined in the report are primarily as a result of cost increases and inflationary pressures to ensure the Council recovers its costs where possible and provides best value to residents and customers.

#### **New annual consent locations**

If an annual consent is granted for a new location other than those listed in Figure 1, the VOA calculation can be applied to that location, to ensure the Part 3 cost of the consent fee remains relative to the existing locations.



### **Street Trading Consent Fee Rationale**

The City of Wolverhampton Council Street Trading Policy was adopted 1 April 2023 following Regulatory Committee review and approval 11 January 2023

As part of the overall Street Trading review and with the return of the Promotional Spaces to the control of the Council, a thorough review of the existing consent application process was required to ensure the application criteria reflects the new policy and to determine if the existing fee adequately covers officer time to process an application.

The application processing tasks have been itemised based on the time required to undertaken them. As a result, application processing tasks have been split into two parts, with a cost allocated to each based on the current officer hourly rate:

- Part 1. **Application processing time** (i.e., officer time to: review the application and all evidence, undertake Highways and Disability Access visits and in-person unit assessment, consult with local businesses) **= £363.58**
- Part 2. **Granting of consent processing time** (i.e., officer time to: set up applicant in all back-office systems, print consents and ID badges, undertake first compliance visit and review further evidential documentation. Includes all their subsequent annual compliance visits) **= £269.29**

The total cost for processing an annual or occasional consent application (Part 1) and subsequent granting of that consent (Part 2) has been calculated at £632.88.

Promotional space application processing time comprises only one part, with less processing tasks and calculated at £137.75. Registered Charities receive a 50% discount on this fee.

Officer time costs align to the hourly rates calculations in Appendix 3 - Commercial Regulation Cost Recovery Policy 2023-2024.

In addition, and as the fees have not been reviewed more than 8 years, it was determined appropriate to ensure the consent fee accurately reflects the location premium. For example, an A Type consent in Dudley Street, City Centre benefits from more footfall than other areas of the City, hence why it currently attains the highest fee of all consent types.

A Part 3 cost has therefore been determined, by using the Valuation Office Agency (VOA) business rates for 1 April 2023 as the source for comparing current business rates, against the existing street trading consent locations across Wolverhampton as listed in Figure 1.

Using Dudley St, City Centre as the baseline (prime) location, the other existing street trading consent locations then have either an increase or decrease calculation applied, against its comparable business rate in the same location.

#### **Proposed Fees Summary**

The proposed fees for 2024 comprise:

- the application processing cost of £632.88 (Part 1 and Part 2); plus
- the appropriate location fee as determined by the relative business rates in the same location (Part 3)

However, it is acknowledged that in some cases the standard VOA calculation would increase some existing consent fees exponentially, which poses the risk of making consents too expensive for existing street traders to continue trading or alienating start-up businesses with a large upfront cost. Discretionary discounts have therefore been applied to selected consent types to encourage trade in Wolverhampton.

The total consent fee is then rounded down.

The key changes can be summarised as follows:

#### **Annual Consents**

- I. Football / Match Day consents have increased by 87% to reflect the number of match / event days that annually take place at the Molineux
- II. Wednesfield Town Centre consents have decreased by 30% to reflect the comparable business rates 1 April 2023
- III. There has been no change to A Type City Centre consents on Dudley Street, Bilston Street, Queen Street, Skinner Street, Cleveland Street, Victoria Street as these are the existing City Centre premium consents
- IV. Evening consents have a discretionary discount of 50% applied (against the Dudley Street baseline location fee), to reflect the lower footfall in the evening economy
- V. Flower seller consents have increased by 14% to cover the cost of the application processing, but have a discretionary 25% discount applied to the overall cost to reflect the nature of their business and low footfall
- VI. Mobile consents and Private Land consents have increased by 44% and 565% respectively, to cover only the application processing time
- VII. Assistant Application Processing has increased by 11% to reflect the application processing time against the application criteria
- VIII. The Consent Variation Administration Fee has increased by 35% to reflect the processing time and hard costs for reprinting the two copies of consents

### **Occasional/Temporary Consents - Day Rates**

- I. The City Centre Day rate has been standardised to £55.00 per day, regardless of how many days booked (day rate discount previously provided for days booked in bulk). The appropriate application processing cost has been waived to encourage trade
- II. The Bilston and Wednesfield town centre day rate has been standardised to £30.00 per day, regardless of how many days booked (day rate discount previously provided for days booked in bulk). The appropriate application processing cost has been waived to encourage trade

- III. The day rate for other areas of the city have been standardised to £15.00 per day, regardless of how many days booked (day rate discount previously provided for days booked in bulk). The appropriate application processing cost has been waived to encourage trade
- IV. Special Outdoor Events (i.e., City Show, Vaisakhi, Steam and Vintage Rally, etc) have been reduced, by applying a 65% discount to the application processing cost to encourage events

#### **Promotional Spaces – Day Rates**

- I. The Bilston town centre day rate has been frozen and standardised to £90.00 per day, regardless of how many days booked (day rate discount previously provided for days booked in bulk). The appropriate application processing cost has been waived to encourage trade
- II. The Dudley Street, City Centre Day rate has increased by 2% and standardised to £140.00 per day, regardless of how many days booked (day rate discount previously provided for days booked in bulk). The appropriate application processing cost has been waived to encourage trade
- III. The Queen Square, City Centre Day rate has been frozen and standardised to £225.00 per day, regardless of how many days booked (day rate discount previously provided for days booked in bulk). The appropriate application processing cost has been waived to encourage trade

# 1.0 Background

As part of the Council's services to the public, Commercial Regulation Services are responsible for protecting people's health, safety and wellbeing, as well as the environment and amenities. They are responsible for promoting economic growth and employment opportunities. In doing so, a cost is incurred by the Council. Where the service the Council provides is discretionary, a charge can be levied so that the authority can recover the costs of providing services. Court costs can also be recovered where the defendant has been found to be in breach of the law.

The fees for licences, permits, registrations and consents are set by the Council, unless the fee is set in statute. The calculation of the fees varies by legislation for licences, permits, registrations and consents, but essentially contains an element of administrative cost, compliance cost and where permitted, an enforcement cost. The Provision of Services Regulations 2009 requires that any charges set by the Council must be set on a cost-recovery basis.

#### Regulators' Code

The Regulators' Code 2014<sup>1</sup> was laid before Parliament in accordance with section 23 of the Legislative and Regulatory Reform Act 2006 ("the Act"). Regulators whose functions are specified by order under section 24(2) of the Act must have regard to the code when developing policies and operational procedures that guide their regulatory activities.

The Regulators' Code provides a flexible, principles-based framework for regulatory delivery that supports and enables regulators to design their service and enforcement policies in a manner that best suits the needs of businesses and other regulated entities. The principles are:

- a) understand and minimise negative economic impacts of their regulatory activities;
- b) minimising the costs of compliance for those they regulate;
- c) improve confidence in compliance for those they regulate, by providing greater certainty;
- d) encourage and promote compliance.

# 2.0 Legal Justification for Recovery of Costs

For costs incurred by legal proceedings, The Civil Procedure Rules 1998 establish that the loser pays the winner's costs in civil matters. For criminal matters, Section 64 of the Magistrates Court Act 1980 allows a party to ask the court to award costs against another at the conclusion of a trial.

For general charging of costs, Section 93 of the Local Government Act 2003 (LGA 2003) gives relevant authorities the power to charge for discretionary services. <sup>4</sup> These are defined as those services authorised by statute that a local authority is not required to provide but may do so voluntarily (Section 93(1)(a), LGA 2003).

Legal authority for general charging of costs (giving the local authority capacity to act) can come from Section 111 of the Local Government Act 1972 authorising the provision of a service to facilitate the discharge of a specific function (using Section 93 to do so). Otherwise, the Localism Act 2011 confers a power on local authorities to charge the individual for providing a service under the general power of competence if:

- a) the service is not one that is required to be provided under an existing statute (Section 3(2)(a));
- b) the individual has agreed to the service being provided (Section 3(2)(b));
- c) there is no conflict between charging powers provided in Section 93 of the LGA 2003 and the general power to charge provided in the Localism Act 2011.<sup>6</sup>

# 3.0 Proposed Cost Recovery

The Council's charging power is intended to allow it to recover the cost of providing services or improvements to services that it may otherwise not have been able to provide. The Council's recovery of costs are designed to facilitate:

- a) ensuring the amelioration of the safety of the public;
- b) minimise negative economic impacts of regulatory activities, minimising the costs of compliance;
- improving confidence in compliance, by providing greater certainty; and
- d) ensuring that Council services provide value for money to the public purse.

#### **Fees**

For the various licences, permits, registrations and consents that are administered within Commercial Regulation, once the policy is agreed, the fees will be updated annually in accordance with the constitution and the costs for the services to provide them.

#### **Discretionary Service Charges**

Services within Commercial Regulation shall continue to provide advice and services free of charge where legislation and statutory guidance dictates. Only enhanced services that are offered above and beyond that already provided, shall attract the discretionary charge.

#### **Cost Recovery**

Court costs cover aspects of the preparation for, and participation in legal action. As the need to incur costs will have come about because of the defendant's breach, it is therefore "just and reasonable" that such costs are borne by the defendant rather than the public purse. The award of costs, however, is ultimately within the discretion of the Court.

The hourly charge basis for all cost recovery and fee setting shall include the additional costs outlined in figure 1:

Direct Costs	Indirect Costs
Salary	Premises and Office Costs
On-costs	Central Function Costs (i.e., HR and Finance)
(Superannuation and National Insurance)	Governance and Management Costs

### 4.0 Cost Breakdown

Including the additional indirect costs identified in figure 1, 73% of the hourly cost for an Officer comes from direct costs for pay, including National Insurance and pension costs. Additional indirect costs comprise 27% of the hourly rate and make up the rest of the hourly cost.

The indirect costs are made up of premises and office costs, central functions, and governance and management.

The final element of the hourly cost for an Officer comes from direct costs. This is made up of salary, National Insurance (NI) and superannuation. This is calculated on a cost recovery practice based on actual hours worked by the Officer taking into account annual leave, bank holidays and administrative time.

Indicatively, in a case where an Officer has spent 37 hours on the case, the costs would be worked out as follows:

Pay, superannuation, and NI per hour	£
Service recharge costs per hour	£
Total cost per hour	£
Cost per hour multiplied by hours worked (37 hours)	£

= £ total cost

The types of roles the cost recovery scheme shall be applicable to are set out in figure 2:

# 5.0 Operational

Through assessing and including indirect costs in an Officer's hourly rate, the rate charged will more accurately reflect the cost of the Officer's time. This would allow the Council to meet the guidance as given by HM Treasury <sup>7</sup> and would be legally justifiable under the statutes outlined in Section 2 of this report.

The applicable costs will be assessed annually in arrears, revising indirect costs and taking agreed pay increases and inflation into account.

### 1.0 Purpose

- 1.1 To seek the endorsement and approval of a proposed decision-making process and the proposed delegations in relation to category 3 decision making powers to the Director of Resident Services.
- 1.2 To draw Councillors' attention to the delegations document attached at Appendix 1 which includes proposed delegations from the Director of Resident Services to officers within Commercial Regulation.

### 2.0 Background

- 2.1 The Regulatory Committee has responsibility for a wide range of licensing functions.

  These relate principally to the issue of licences, permits, registrations, consents and their enforcement.
- 2.2 Councillors will be most familiar with taxi related matters. However, there are many other matters that are only occasionally brought to Councillors' attention for consideration e.g. sex establishments.
- 2.3 The licensing system is configured to allow the proper discharge of functions and operates through the Regulatory Committee either taking decisions themselves or through the delegation of decisions to officers.
- 2.4 The aim of the delegation scheme is the achievement of a proper balance of responsibilities to enable the service to be delivered in an efficient and effective manner.
- 2.5 The current approval arrangements categorise decisions into three categories:

### 3.0 Delegation of Category 2 and 3 Decisions

- 3.1 On 30 May 2012 the Licensing Committee considered a report on the review of decision making.
- 3.2 This report set out a review process for officer delegations.
- 3.3 Licensing Services produced a policy document which included a list of current and proposed delegation to officers for a range of decisions.
- 3.4 The Licensing Committee confirmed and endorsed category 2 and category 3 decisions and the continuation of the existing regime of officer delegations and approved delegation of category 3 decisions, to the Strategic Director for Education and Enterprise. This ensured the ongoing delivery of routine, non-contentious licensing functions in accordance with agreed policies and procedures.
- 3.5 Councillors agreed that an updated delegation report be presented to Committee on an annual basis to the first meeting of the municipal year.
- 3.6 The Regulatory Committee are asked to endorse and approve the delegation of category 3 decision making to the Director of Resident Services.
- 3.7 The delegations document attached at Appendix 1 has been updated throughout the year and includes proposed delegations from the Director of Resident Services to officers within Commercial Regulation.
- 3.8 Should Councillors agree with recommendations within this report the proposed delegations document will be authorised by the Director of Resident Services.

### 4.0 New Driver Licence Applicant Hearings

4.1 The following table summarises the data in Appendix 2.

4.2 It should be noted that whilst the number of hearings undertaken has nearly doubled, the grant rate is consistent with last year. Deferrals have increased, likely for more information from other licensing authorities as last year saw a greater proportion of applicants from other councils who were already licensed drivers.

- 5.2 It should be noted again that whilst the number of hearings has nearly doubled, the proportion of revocations and immediate revocations is consistent.
- 5.3 Notably, the number of deferrals, suspensions and no further action has increased significantly. This is due to the issues drivers face with the Disclosure and Barring Service (DBS) Update Service. Drivers are now required to maintain a DBS Update Service subscription throughout the lifetime of their licence. This allows the Council to undertake daily checks of their criminal record, a frequency which no other council matches, with most undertaking six-monthly checks.
- 5.4 However, this service comes at a cost to the driver, in the form of a £13 annual subscription fee. It is a condition of licence that drivers must maintain this subscription. Unfortunately, this subscription is paid by recurring card payment, rather than direct debit. This means that if a driver receives a new bank card and does not take action to update their card details, the payment fails and the subscription will terminate. The Council is notified of this termination and drivers are required to purchase a new DBS

certificate at a cost of £53.49. Where a driver fails to do this, they are required to attend a review where the licence is normally suspended until a new certificate is provided. Once the certificate is provided, no further action is normally taken.

5.5 The Council has written to the DBS to lobby for Direct Debit payments; however the response was that this facility is not planned.

### 6.0 Licensing Decision Appeals

6.1 As the number of licence application and review hearings has increased, the number of appeals has also increased. Whilst there has been an increase in the number of appeals upheld against the Council, it is difficult to draw conclusions from the data due to the low overall number of upheld appeals. The rate at which appeals have been upheld over the last five years has been inconsistent, showing no overall trend.
