I am writing to you as a Responsible Authority to inform you that the Trading Standards Service is requesting the City of Wolverhampton Council to review the Premises Licence for Super Mahan, 31 Thornley Street, City Centre, Wolverhampton.

This follows: -

- The seizure on the 5 July 2019, of 880 illegal cigarettes sticks (44 packets of 20), 200g of illicit hand rolling tobacco and 171 Subutex tablets, a pharmacy controlled Class C drug, discovered on the premises of Super Mahan, 31 Thornley Street, City Centre, Wolverhampton.
- The underage sale of a single can of Blackstorm Cider, at 7.5% ABV and 20 City MS Minsk (foreign and non-UK duty paid) cigarettes to a child under the age of 18 on the 5 July 2019 from super Mahan.
- The sales of a single bottle of Dragon Stout high strength alcohol to a person aged 18 from Super Mahan.
- The discovery of 40 NZ Gold foreign cigarettes on the 5 July 2019 and 80 NZ
 Gold foreign cigarettes and 60 Bahman foreign cigarettes discovered on the 27
 September 2019 at 31 Thornley Street.
- Persistent breaches of licence conditions at Super Mahan despite written and oral warnings to the contrary.

| Please state the ground(s) for review (please read guidance note 1) The local weights and measures authority has "responsible authority" status under the Licensing Act 2003 by virtue of the Licensing Act 2003 (Premises licences and club premises certificates) Regulations 2005. |
| On the 5 July 2019, Trading Standards was informed that following the execution of a drugs warrant on or around the 30 June 2019, West Midlands Police had seized 171 Subitex tablets, a controlled Class C drug, 880 illicit cigarettes and 200g of foreign labelled hand rolling tobacco from Super Mahan, 31 Thornley Street, Wolverhampton, a licenced premises in the City Centre. The cigarettes included 300 Gold NZ Compact cigarettes and 420 Minsk cigarettes. |
| On 5 July 2019, an underage test purchase of alcohol and tobacco was made at the premises. A single can of Blackstorm Cider, at 7.5%ABV and 20 Minsk cigarettes, that were not in plain packaging, bore only foreign warnings and were not UK duty paid, were sold to a female volunteer aged 15 years. The physical seller was later identified as The sale was captured on the CCTV belonging to the shop and recorded by the Police and also witnessed by an officer from Licensing Services. |
| A criminal offence was committed under Section 146(1) of the Licensing Act 2003 of selling alcohol to a person under 18. An offence was also committed under Section 7 of the Children and Young Persons Act 1933 (as amended), of selling a tobacco product to a person under 18 years. There was no attempt to ask the volunteer her age or ask for identification. |
| To sell a high strength single can of alcohol is a breach of condition 10. listed on the |

Premises Licence for Super Mahan, under the licensing objective of 'PREVENTION OF CRIME AND DISORDER'.

Later that afternoon, on the 5 July 2019, Trading Standards visited 31 Thornley Street accompanied by Police Officers.

2 packs of Gold NZ Compact foreign cigarettes (40 cigarette sticks) were discovered under the counter top in a tin.

The cigarette gantry was open exposing tobacco products for sale, contrary to the Tobacco Advertising and Promotion (Display)(England) Regulations 2010. There was no statutory tobacco notice on display contrary to the Children & Young Persons (Protection from Tobacco) Act 1991.

There was no refusals book available to inspect, contrary to condition 6., under the Licensing Objective, 'For the prevention of Crime and Disorder' and condition 3. of the Premises Licence for the licensing objective 'FOR THE PROTECTION OF

inspection. The tobacco products were suspected of being non duty paid and were

A traders notice was left with Mr Mahani.

subsequently seized.

On the 9th July 2019, Mr Mohammed Sokhanvar Mahani was invited to and attended a voluntary recorded PACE interview in the presence of his solicitor and an interpreter.

On the 3rd September 2019, I was informed that a Licensing Apprentice aged 18 was able to purchase a single 284ml bottle of Dragon Stout contrary to Super Mahan's Conditions on the Fremises Licence which states "No single sales of cans or bottles of beer, lager or cider, up to and including one litre, shall be sold from the premises if they have an (Alcohol By Volume) ABV above 6.5%". I was also informed that the apprentice was not asked for identification to prove his ag, despite Super Mahan operating a Challenge 25 policy at Condition 2., PROTECTION OF CHILDREN FROM HARM.

On the 27 September 2019, Trading Standards was informed that a single bottle of high strenth Dragon Stout was again sold to an 18 year old, contrary to Super Mahan's licence condition of not selling single cans and bottles of alcohol over 6.5%. However, identification was asked for on this occasion.

Later that evening officers from Trading Standards and West Midlands Police visited Super Mahan with a tobacco detection dog. Again the contents of the cigarette gantry were exposed for all the public to see. 4 packs of 20 Gold NZ cigarettes and 3 packs of 20 Bahman cigarettes were discovered in the stair well behind the shop area. These tobacco products were seized. All cans and bottles of beer, lager and cider over 6.5 % ABV were also seized due to the breaches of the licensing conditions.

The seized tobacco goods are known as ' foreign cheap whites', and includes brands such as Minsk, and NZ which are foreign brands brought into the UK illegally specifically to be sold on the black market. They display foreign warnings and labelling and were seized because they breached UK regulations and were non UK DUTY paid.

To knowingly keep or allow to be kept on relevant premises, goods such as cigarettes, which have been imported without payment of duty or which had otherwise been unlawfully imported is a criminal offence as per section 144 (1) and (3) of the Licensing Act 2003.

Trading Standards has "responsible authority" status under the Licensing Act 2003. Super Mahan, has engaged in activities which have breached licensing objectives namely the prevention of crime and disorder and protection of children from harm. The Home Office publishes guidance under section 182 of the 2003 Act and at paragraph 11.27 the guidance advises that

"the sale of contraband or counterfeit tobacco is activity that should be considered "partcularly seriously." The guidance goes on to state that:

"Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that suspension or revocation of the licence — even in the first instance should be seriously considered."

Additionally the sale of illicit tobacco:

-contributes to the shadow ecomony

-undermines the City's public health activity which aims to deter residents from smoking especially young people

-drives down the cost of tobacco to pocket money prices, thereby counteracting Central Government's attempts to use price as a disincentive.
