The local weights and measures authority has "responsible authority" status under the Licensing Act 2003 by virtue of the Licensing Act 2003 (Premises licences and club premises certificates) Regulations 2005.

On the 25 February 2020, following the receipt of information, Trading Standards Service organised a covert test purchase of illicit tobacco from the premises known as Salvo's Convenience. A packet of 20 Richmond cigarettes were sold to the purchaser for £4.00, believed to be counterfeit. A statement has been provided.

On the 5 March 2020, Officers from the Trading Standards Service, West Midlands Police and a tobacco detection dog and his handler, visited Salvo's Convenience, accompanied by Police Officers.

The cigarette gantry was open exposing tobacco products for sale, contrary to the Tobacco Advertising and Promotion (Display)(England) Regulations 2010.

The manager of Salvo's who was present was identified as [REDACTED]. Mr Angelo Salvo, the owner of the business, premises licence holder and designated premises supervisor subsequently turned up during the inspection.

Illegal tobacco products were discovered in the shop premises including suspected counterfeit Richmond cigarettes; Duty Free marked LIFA Menthol cigarettes and cheap white Richman cigarettes which are foreign brands brought into the UK illegally specifically to be sold on the black market. English branded hand rolling tobacco products such as Golden Virginia, that bore foreign warnings were seized because they breached UK regulations on packaging and/or labelling and were non

UK DUTY paid. Seven Sildamax Sildenafil Citrate 100mg tablets, a pharmacy controlled drug used to treat erectile dysfunction were discovered behind the counter. In a van outside the shop, belonging to the manager , a further 1160 packets of 'Duty Free Only' marked LIFA Menthol cigarettes and 329 Sildamax Sildenafil Citrate 100mg tablets were discovered. Pharmacy medicines such as Sildenafil Citrate may only be legally sold or supplied to the public through registered pharmacy premises, by or under the supervision of a pharmacist. Salvo's Convenience has not been given authorisation to sell such medicines and to continue is a breach of Regulation 255, 214 and 46 of the Human Medicines Regulations 2012. Photographs are attached.

Angelo and the manager were both advised during the inspection that it was a criminal offence to possess, supply or sell counterfeit products or illicit tobacco products.

On the 20 February 2015, a written warning was issued to Salvo's Convenience in respect of a previous seizure of illicit tobacco products that were found on the premises. A copy is attached

To knowingly keep or allow to be kept on relevant premises, goods such as cigarettes and hand rolling tobacco, which have been imported without payment of duty or which had otherwise been unlawfully imported is a criminal offence as per section 144 (1) and (3) of the Licensing Act 2003.

Trading Standards has "responsible authority" status under the Licensing Act 2003. Salvo's Convenience has engaged in activities which have breached a licensing objective namely the prevention of crime and disorder. The Home Office publishes guidance under section 182 of the 2003 Act and at 11.27 that guidance advises that the sale of contraband or counterfeit tobacco is activity that should be considered "particularly seriously." The guidance goes on to state that:

"Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that suspension or revocation of the licence – even in the first instance should be seriously considered."

Additionally the sale of illicit tobacco:

- contributes to the shadow economy
- undermines the City's public health activity which aims to deter residents from smoking especially young people
- drives down the cost of tobacco thereby counteracting Central Government's attempts to use price as a disincentive.

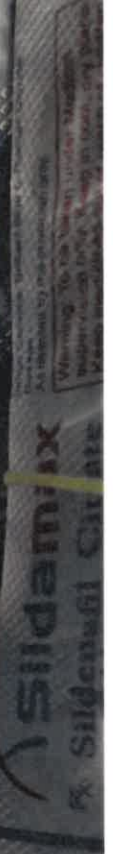
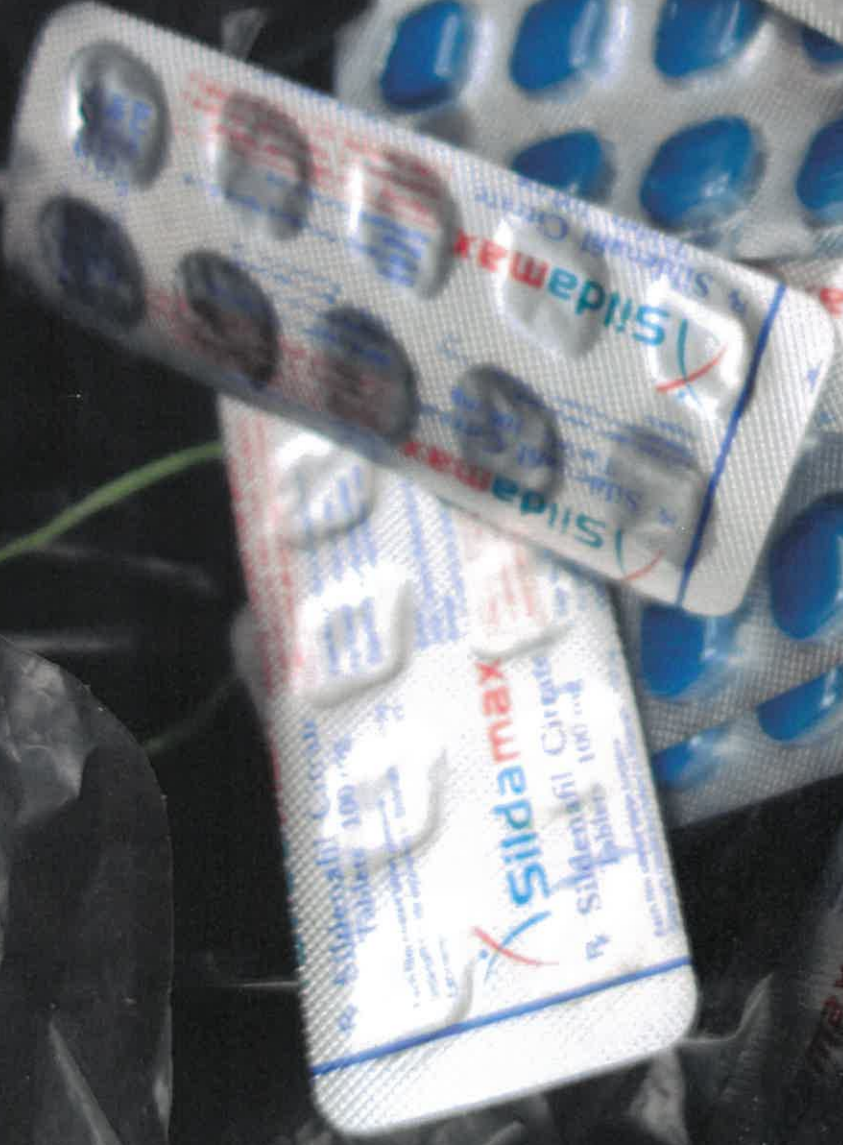

REGULATORY SERVICES: TRADING STANDARDS FORMAL WARNING

The Consumer Protection Act 1987.

On the 11 September 2014, as a result of a complaint to Regulatory Services, Trading Standards conducted an inspection of your business premises known as Salvo's Convenience with the assistance of West Midlands police and tobacco search dogs. During this inspection hidden in various locations within your business, the following items were discovered:

- 454 cigarette sticks identified as cheap foreign whites (Fest Red and Fest Blue);
- 600 grams of foreign labelled Golden Virginia and Amber Leaf hand rolling tobacco.
- In a bin behind the counter, a discarded 200 cigarette sleeve was also found for 'Presidents' cigarettes also identified as cheap foreign whites.

Under the Tobacco Products (Manufacture, Presentation & Sale (Safety) Regulations 2002, (as amended), it is prohibited to have in your possession for retail supply non-compliant tobacco products that do not display the required health warnings in English. For example, each packet of cigarettes must carry on the most visible surface one of the following warnings;

- Smoking kills, or,
- Smoking seriously harms you and others around you.

On the other most visible surface an additional health warning must be in the form of a picture warning.

As owner of the business you are liable for the actions of your staff as well as yourself and carry a responsibility to ensure all people, including your family, who work in your store, or purchase goods on behalf of your business, comply with the law. When goods are obtained in connection with the business, or stored on the property, you must ensure that they are legally compliant. Further you should have proper receipts and traceability of where the goods have come from, to enable contact with your supplier by yourself, or by relevant enforcement officers. If you cannot establish who supplied the goods then the responsibility will rest with you as owner of the business. If legal proceedings are taken against you and you are found guilty, you may face a fine, imprisonment or both.

It has been noted that you fully cooperated with officers. On this occasion the Service wishes to conclude the matter by means of a written **Formal Warning**. Please sign the enclosed surrender notice and return it within 7 days. This warning will remain on file for three years, and should similar circumstances occur in future then this warning will be taken into account when considering whether to instigate legal proceedings.
