Blakenhall

This is the proposal document for Blakenhall. Within this document there is district and ward data relating the number of registered voters (ward/district context), and the reasons for the proposals. In this particular case data has been less of a driver for change; health and safety concerns about Assembly Hall have been the main driver for the proposal.

Ward/District Context

The table below ranks the polling stations in Blakenhall according to the proportion of the registered electors in the ward that use the stations. The percentage is colour coded according to the performance quartile the station fits into across the City.

• Lowest quartile: 0% - 11.03%

Lower middle quartile: 11.30% -14.40%
Upper middle quartile: 14.47% - 17.17%

• Upper quartile: 17.21%- 31.18%

- Remove polling place at Assembly Hall due to health and safety implications.
- Absorb JIA voters at Goldthorn Park Primary, with district boundaries remaining.

Reason

This proposal is driven by circumstance and not performance. Whilst Assembly Hall is a successful station, the council will no longer be able to use it due to health and safety issues meaning that the station would not be safe to use. The JIA district does not have any other obvious polling places where the station could be moved to apart from Colton Hills Community School. This would not be an ideal location as the council does not currently the school for electoral matters and would therefore be quite risky and complicated.

As an alternative, Goldthorn Park Primary School could be used to accommodate voter in JIA. The school is within a reasonable distance to Assembly Hall and would not represent an unreasonable distance for voters to travel to from JIA. It would be preferable to Colton Hills School as it is a 'tried and tested' station and has the capacity to absorb a substantial amount of voters. It is also preferable for the following reasons:

- The school currently closes on Election Day, so extra numbers would not cause problems in terms of disruption to pupils on the day.
- Goldthorn Primary is a large polling place meaning that extra polling stations could be introduced on site depending on the scale and type of election.
