1.0 Background

1.1 The Scheme of discretionary rate relief for charitable and not for profit organisations was approved by Cabinet (Resources) Panel on 5 February 2019. The Panel also delegated authority to the Cabinet Member for Resources in consultation with the Head of Revenues and Benefits to grant awards under the scheme.

2.0 Awards of discretionary relief

- 2.1 All applications have been considered against the agreed scheme and verified through appropriate supporting evidence.
- 2.2 Appendix 1 includes further detail of the awards submitted for approval.

3.0 Evaluation of alternative options

3.1 This award is made in line with Council's discretionary relief policy and therefore the alternative option, not to award relief, is not considered appropriate.

4.0 Reasons for decision

4.1 The discretionary relief scheme supports charitable and not for profit organisations that provide facilities for local people that complement those provided by the Council or relieve the Council of the need to provide such facilities.

5.0 Financial implications

5.1 The City of Wolverhampton Council, as one of the constituent members of the West Midlands Combined Authority, is participating in a business rates retention pilot from April 2017, on a no financial detriment basis. The continuation of the existing 100% business rate retention pilots into 2019-2020 was confirmed as part of the final Local Government Settlement issued on 29 January 2019. As a result of entering into this pilot, the Council will retain 99% of business rates, no longer receive revenue support grant and receive a top up grant adjustment to account for the net effect of the changes. Therefore, under the 99% business rate retention scheme, the cost to the Council of awarding this relief in 2019-2020 will be in the region of £1,620.

- 6.1 Section 47 of the Local Government Finance Act 1988 gives discretionary power to billing authorities to grant partial or full relief to certain categories of non-domestic ratepayer. The Non-Domestic Rating (Discretionary Relief) Regulations 1989 allow for this relief to be restricted to a fixed period.
- 6.2 It will be for the Council to ensure that any relief granted does not transgress state aid rules.
