

INSTRUMENT OF GOVERNMENT

1. The name of the federation is Christ Church (Church of England) Infant School and Nursery and Christ Church (Church of England) Junior School
2. The names of the schools that the federated Governing Board will be responsible for are: Christ Church CE(C) Infant School and Nursery and Christ Church CE(C) Junior School
3. The schools are Voluntary Controlled Schools.
4. The name of the Governing Body is "The Governing Board of the Federation of Christ Church (Church of England) Infant School and Nursery and Christ Church (Church of England) Junior Schools"
5. The Governing Body shall consist of:
 - a. Two Parent Governors
 - b. One LA Governor
 - c. One Staff Governor
 - d. One Executive Headteacher
 - e. Four Foundation Governors
 - f. Five Co-opted Governors
6. Total number of Governors is fourteen (unless the Executive Headteachers resigns the office of Governor in accordance with regulation 19 of the Constitution Regulations 2012, in which case the total number of Governors shall be 13)
7. The Lichfield Diocesan Board of Education shall appoint 3 Foundation Governors
- 8(a) The holder of the following office shall be a Foundation Governor

Ex Officio

The Principal Officiating Minister of the Parish of Tettenhall Wood

Christ Church

- 8(b) The Archdeacon of Walsall shall be entitled to appoint a Foundation Governor to act in the place of the ex-officio Foundation Governor whose governorship derives from the office named in (a) above, in the event that the ex-officio Foundation Governor is unable or unwilling to act as a Foundation Governor, or has been removed from office under Regulation 21(1) of the Regulations or there is a vacancy in the office by virtue of which his/her governorship exists

9 The Archdeacon of Walsall shall be entitled to request the removal of any ex-officio Foundation Governor and to appoint any substitute Governor

10 The schools were established as church schools on 10 March 1874 by a conveyance between Miss Theodosia Hinckes and the Minister and Churchwardens of the Parish of Tettenhall Wood. This status was confirmed on 30 December 1974 by a Deed of Exchange between the Council of the Borough of Wolverhampton and the Vicar and Churchwardens of the Parish of Christ Church Tettenhall Wood. The Minister and Churchwardens of the Parish of Tettenhall Wood Christ Church are the trustees of the Schools.

11 "Recognising their historic foundation, the Schools will preserve and develop their religious character in accordance with the principles of the Church of England and in partnership with the Church at parish and diocesan level.

The Schools aim to serve their communities by providing an education of the highest quality within the context of Christian belief and practice. It encourages an understanding of the meaning and significance of faith, and promotes Christian values through the experience it offers to all its pupils."

12 This Instrument of Government comes into effect on 1 April 2021
