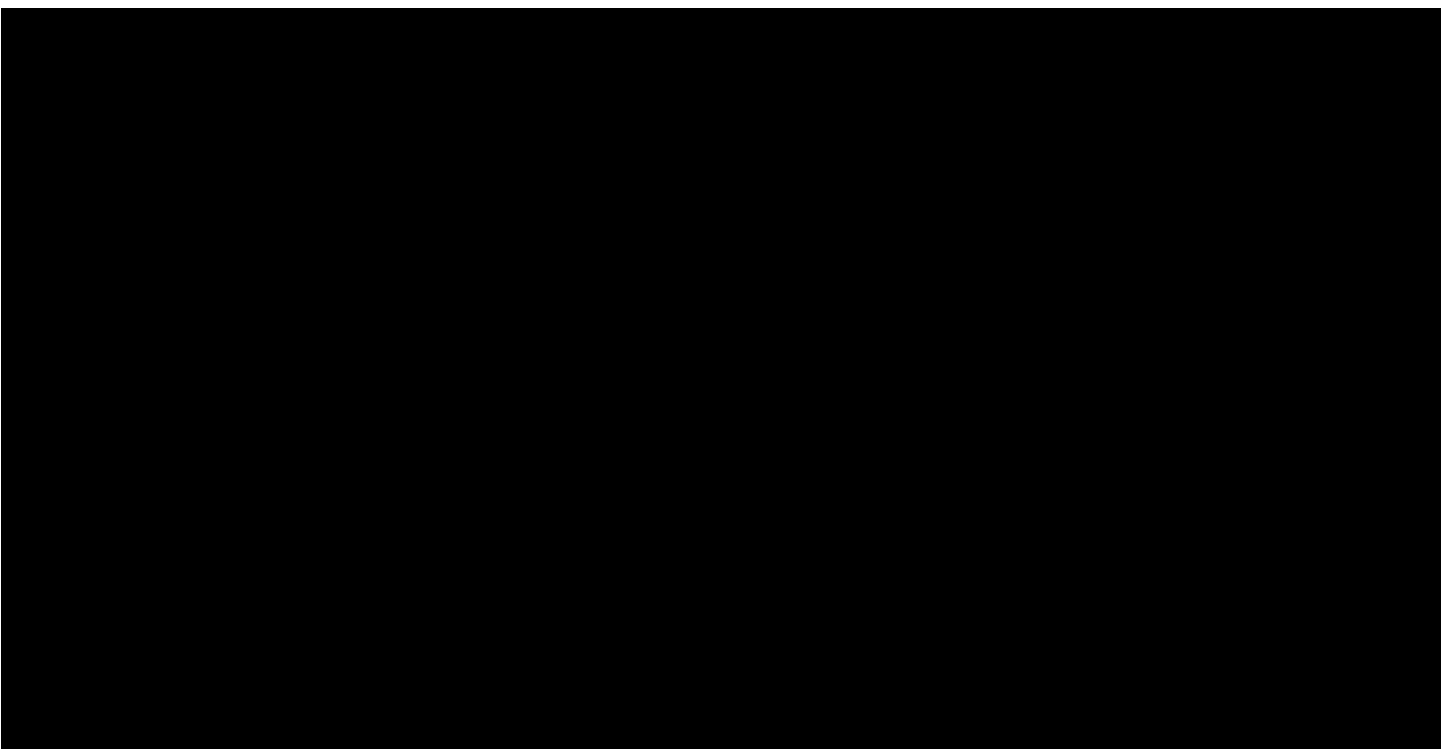
[REDACTED] Also units on estate have crime and disorder safety issues for their units. Children issues as there is a skate park on front of estate so they might file protection from children harm.


Some reason this property is not registered as what it does already as Dark Arts Studio with same address different post code to now be registering as a Myla cocktail bar with same address different post code.

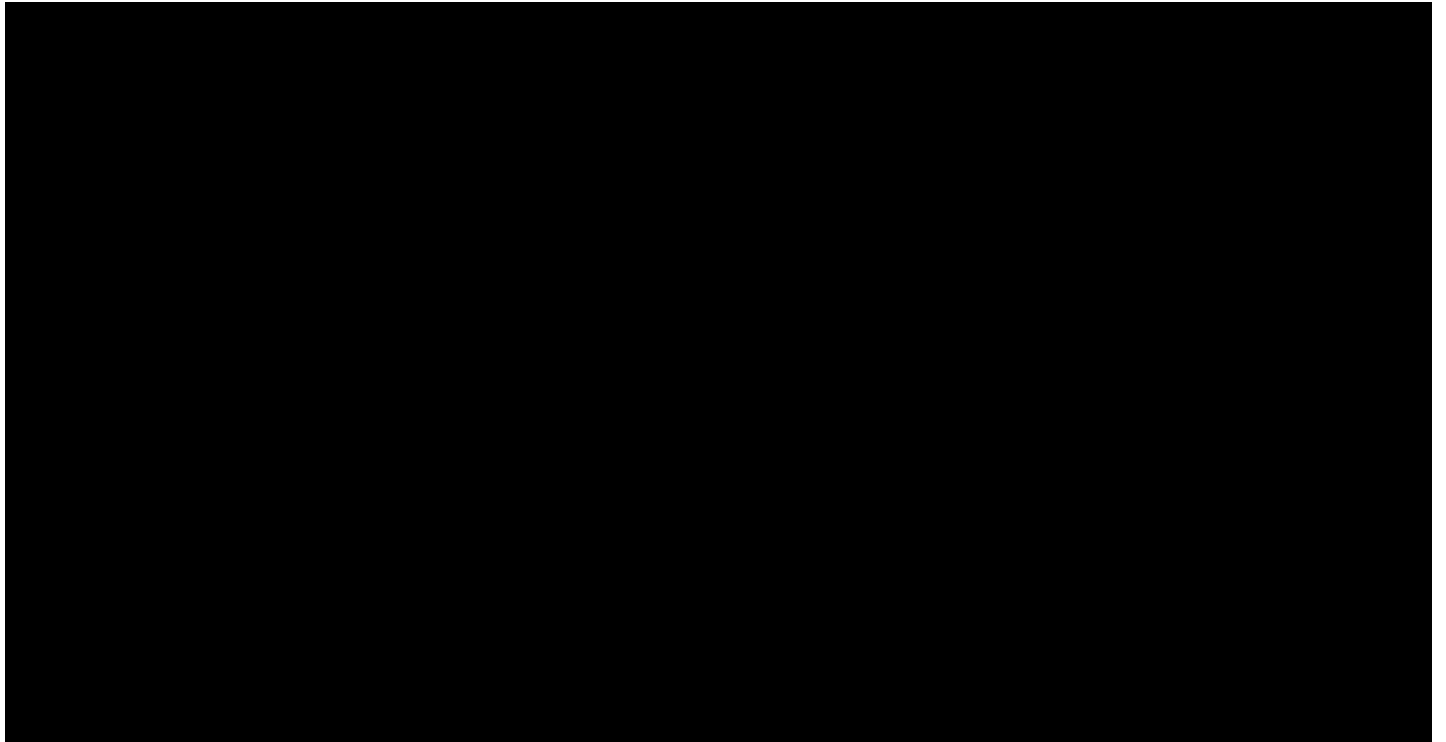



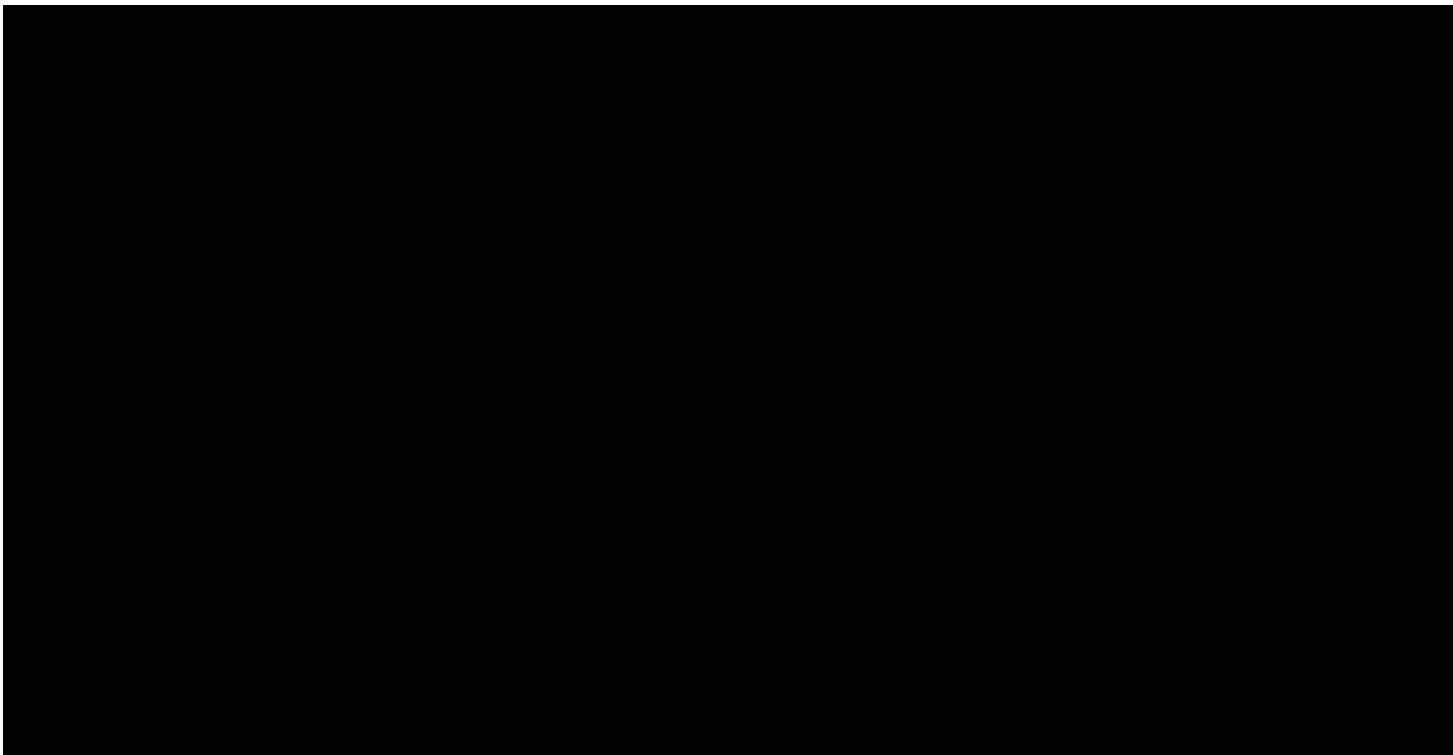
