Dear Licencing Team,

I am writing to put forwards a representation against the application for a Premises Licence at 327 Dudley Road for company number 10225710.

This is on the grounds the correct licensing application procedure has not been adhered to due to incorrect display of public notice. The current public notice in place on the perimeter of this premises was not displayed for the correct time of 28 consecutive days on the premises as per the Licensing Act Requirements. This was earlier before last week removed in replacement of Diwali alcohol sales posters as can be seen from the picture attached.

I am also not aware of any attempt to publicly make local residents aware within a local newspaper which I am a keen reader of.

With this contravention of the Law on display of notice correctly I therefore write to reject the application on these grounds.

Additionally having been a local resident for many years I would like to add comment to what has happened since this site has reopened. Since the reopen the levels of antisocial behaviour and crime has only risen in the nearby streets. Many people can be seen going into here very late at night to buy alcohol to then sit on the nearby walls in local streets and also across the road in the park. These parties have contributed to the many fights, antisocial behaviour and alcohol-fueled crime that has now suddenly spiked in the area. I no longer feel safe going outside of my own front door at any time during the night for this fear. On one occasion myself and my daughter were threatened by one such group. Unfortunately this petrol station has only provided a place where large gangs come late at night and cause trouble. I am told that a lot of this is due to the high strength beers they sell so cheaply to anyone which I was told by another local resident they should not be allowed to sell as singular cans yet still continue to do so.

With this in mind I would also like this to be taken in as representation against providing the new Licence and hope that the safety of local residents can be prioritised at this important time.

I look forward to hearing from yourself with acknowledgement of this via email and the further outcome.
