## **Mandatory Conditions**

#### Mandatory conditions where licence authorises supply of alcohol

- (1) Where a premises licence authorises the supply of alcohol, the licence must include the following conditions:
- (2) The first condition is that no supply of alcohol may be made under the premises licence:-
  - (a) At a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended
- (3) The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- **4.** (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

## **Conditions consistent with the Operating Schedule**

#### General

We have a number of shops throughout the West Midlands, we have been in the trade for over 30 years. We fully understand the importance of the four licensing objectives. First and foremost we install remote CCTV cameras, all with hard drive back up in house and also online. This enables both us and the authorities to access video footage whenever that may need both inside and outside the shop.

We ensure that all our staff hold personal licences or have been fully trained by a third party on the laws governing the laws governing the sale of alcohol. We are in business to make money. The licence for the shop is of utmost importance and under no circumstance risk losing the licence by infringment of any of the four objectives.

## The prevention of crime and disorder

CCTV is a big deterent when it comes to policing shops. With past knowledge we have come to accept that initially there will be some disorder at the start of trading as the youths in the area try and figure out how far they can push the new shop keeper. Along with the cameras we will be installing LED spot lights to the front of the shop. The directional lighting will ensure the areas we need illuminate putside the shop area; and with zero light pollution the neighbours will not be effected by the lights.

We will also not tolerate any loittering outside the shop. This is annoying for us all, us the owner, neighbours surrounding the shop and it also deters customers who will want to use the shop.

# Public safety

Fire extinguisher will be clearly visible in the shop along with fire blankets. We are in the process of rewiring the shop and also installing brand new cooling unit and fridges which will ensure that there are no fault appliance in the store. The fire exits in the shop will be clearly illuminated.

## The prevention of public nuisance

Public nuisance effects everyone, shopkeeper, neighbours and the general public. We will ensure that all people loittering outside the shop will be moved. We will encourage the youth not to hang around the shop and cause a nuisance. We will also be monitoring school kids and

youth whilst they are in the shop to ensure that they do not shoplift.

#### The protection of children from harm

We will ensure that all staff take alcohol awareness courses. We will endeavour that all the staff hold personal licences. We will also highlight to the general public that buy alcohol for a minor is a serious offence and if anytime the authorities ask for information and request CCTV footage it will be provided.
