**NOTICE IS HEREBY GIVEN** in accordance with Section 19(1) of the Education and Inspections Act 2006 as amended by the Education Act 2011 and The School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2013, that the City of Wolverhampton Council (Civic Centre, St Peter's Square, Wolverhampton WV1 1RL) intends to make the following prescribed alterations to the community schools listed below:

**Penn Hall School, Vicarage Road, Penn, Wolverhampton, West Midlands, WV4 5HP**  
It is proposed that with effect from 1 September 2019:

- The capacity of Penn Hall School is increased from 76 places to 100 places.
- The type of needs that Penn Hall School is registered to cater for are extended from Physical Disability to Physical Disability, Severe Learning Difficulty, Profound and Multiple Learning Difficulty and Autistic Spectrum Disorder.

**Tettenhall Wood School, Regis Road, Tettenhall, Wolverhampton, West Midlands, WV6 8XF**

It is proposed that with effect from 1 September 2019:

- The capacity of Tettenhall Wood School is increased from 102 places to 120 places.
- The age range of Tettenhall Wood School is changed from 5-19 to 4-19.

**Warstones Primary School, Warstones Road, Penn, Wolverhampton, West Midlands, WV4 4LU**

It is proposed that with effect from 1 September 2019, a 12-place resource base for pupils with Hearing Impairments is established at Warstones Primary School.
