

Statutory Register of Councillors' Interests
(Pursuant to Wolverhampton City Council's Code of Conduct for
Councillors, Section 29 of the Localism Act 2011 and the Relevant Authorities
(Disclosable Pecuniary Interests) Regulations 2012)

Notice of Registrable Interests

I, WALERIE EVANS

a Councillor/Co-opted Member of Wolverhampton City Council give notice that I have set out below, under the appropriate headings, interests which I am required to declare under Wolverhampton City Council's Code of Conduct for Councillors. I have put "None", where I have no such interest under any heading.

Registration of Interests

Within 28 days of election or appointment to office a Councillor/ Co-opted Member, spouse, civil partner or person living with the Councillor/Co-opted Member as husband, wife, or civil partner of which the Councillor/Co-opted Member is aware must register their Disclosable Pecuniary Interests and other interests in a public register maintained under section 29 of the Localism Act 2011 by providing written notification to the Monitoring Officer. This form must be used to record those interests.

Changes to Registered Interests

A Councillor/Co-opted Member must, within 28 days of becoming aware of any change to the interests specified in the Register, provide written notification to the Monitoring Officer of that change by completing a fresh form.

Sensitive Interests (Section 32)

Where a Councillor/Co-opted Member considers that information relating to any of his/her Disclosable Pecuniary Interests is a sensitive interest the disclosure of which would in the opinion of the Councillor/Co-opted Member and Monitoring Officer lead to violence and intimidation, the Register will not include details of sensitive interests but will state that details are withheld under Section 32 of the Act.

The Councillor/Co-opted Member must, within 28 days of becoming aware of any change of circumstances which mean that the information excluded is no longer sensitive information, notify the Monitoring Officer asking that the information be included in the Register of Councillors' Interests.

Disclosable Pecuniary Interests

Sponsorship – any payment or other financial benefit (other than from the Council) within the relevant period (12 months) for any expenses incurred in carrying out duties as a Councillor/Co-opted Member, or towards your election expenses, including payment or financial benefit from a Trade Union:

3. Contracts – any contract between you (or a body in which you have a beneficial interest) and the Council:

- (a) for the provision of goods, services or works; and
- (b) which has not been fully discharged:

5. Licences – any licence (alone or jointly with others) to occupy land in the area of the Council for a month or longer:

7. Securities – any beneficial interest in securities of a body where:

- (a) to your knowledge, the body has a place of business or land in the area of the Council; and
- (b) either:
 - (i) the total nominal value of the securities exceeds £25,000 or 100th of the total issued share capital of the body; or
 - (ii) if the share capital is of more than one class, the total nominal value of the share of any one class in which you have beneficial interest exceeds 100th of the total issued share capital of that class.
