## Planned key actions – 2021-2022

- Strategy Development and Implementation concerted multi-agency focus on co-production of overarching Joint Commissioning Strategy and all age Autism Strategy
- Culture of Inclusion and Belonging Programmes build on current momentum of workstreams through agreed action plans to improve educational engagement of vulnerable learners through: support and challenge to promote inclusive practice; improving pathways and support for vulnerable learners; more effective and accessible assessment and review processes; a broader alternative provision offer
- Support for mental health and emotional wellbeing CAMHS transformation; jointly commissioned emotional wellbeing service; Mental Health Support Team for schools trailblazer; a coordinated city-wide training offer
- Enhanced social work expertise of SEND embedded SEND champions across social care via DSCO and SENDIASS
- **Preparation for Adulthood** rigorous focus on transitions and collaborative planning towards post 16/19
- Short Breaks review implementation ensuring fair access for families
- Embedded SEND leisure offer building on successful HAF programme
- Effective response to parent/carer/young people surveys listen, hear, act; embed tell it once

Wolverhampton SEND Partnership Board

- In summer 2021 SEND V4P worked with providers to organise and plan SEND appropriate activities, following the Easter Activity programme and feedback from Parent Carers
- V4P worked with the local authority, parents and young people in coproducing the summer programme which resulted in an exciting, accessible, fun offer with £60,000 being spent on SEND specific activities:
- 533 children and young people took part in the SEND specific leisure actives over 28 days
- 1740 places were allocated to a wide range of activities over these days including animal handling, environmental sessions arts and crafts, plus inspirational outdoor activities such as horse riding, outdoor pursuits which included orienteering, abseiling and fishing which are not usually seen as accessible to SEND children and young people.
- This gave access to opportunities for CYP to challenge themselves and to be able to try new things
  without pressure or judgment in a truly inclusive environment.

#### **SEND Local Area Inspection**

- Phone call received 13<sup>th</sup> September
- Submission of SEF and additional evidence by 16<sup>th</sup> September
- 4 inspectors on site (2 CQC, 2 Ofsted) 20th to 24th September
- Additionally, 2 QA inspectors over the on-site week also reviewing evidence pre and post inspection
- Initial meeting 20<sup>th</sup> September with key colleagues across the Partnership
- Evidence gathered through focus groups, school visits, case file audits, online surveys
- 'Unofficial' feedback received on 24 September 2021
- Letter of findings expected by end of October 2021

### Key messages

- ✓ Warm welcome and excellent levels of engagement from officers, parents, carers, children and young people
- √ School visits informative and enjoyable
- ✓ The Local Area knows itself well, it's strengths and what needs to improve
- ✓ Everyone is committed to SEND, it has a high profile in the Council and across the partnership with everyone passionate about improving outcomes for SEND children and young people
- ✓ Special school settings provide excellent support and provision
- ✓ Emotional Health and Wellbeing offer positive
- ✓ SENDIASS and Outreach services provide excellent support to families and schools
- ✓ Health well engaged through CCG and Designated Medical Officer
- ✓ Healthy Child Programme well embedded
- ✓ Multi disciplinary wrap around support for Early Years (Gem Centre) highly valued and very effective
- Variability and inconsistency in identification of SEND at statutory school age
- Timeliness and quality of EHCP's and annual reviews
- Strategic joint commissioning not clearly evident although happening operationally
- Implementation of strategic plan for Co-Production
- Inconsistencies in transitions (Early Years to starting school and Post-16/18)
- Local Offer and information to ensure all stakeholders can gain and access the same information at the same time
