



**Good Morning Bruce** 

Thank you for meeting with Emily and myself on Tuesday (15/11/22).

To reiterate the following issues were discussed;

- Wolverhampton City Council are in receipt of noise complaints emanating from the Pheasant Pub and have been since it opened in 2020 with Wayne Parkes as the DPS.
   Some of these complaints have been forwarded by Local Councillors and a Local MP.
- The complaints originally related to entertainment noise (amplified music) from the garden area which necessitated the service of a Noise Abatement Notice pursuant to the Environmental Protection Act 1990 served in the 12<sup>th</sup> September 2020 ( see attached).
- The Covid Pandemic obviously impacted on the Entertainment Industry and as we moved out of the pandemic the council deemed it necessary to have a softer touch towards such business and despite complaints and subsequent monitoring by Council Officials did not take any formal action.
- Noise monitoring by myself on the evening of the 6<sup>th</sup> November 2022 revealed that the pub were struggling to control noise from within the premises, Amplified music was audible along the full length of Prestwood Avenue and low frequency noise was clearly perceptible within adjacent properties.
- A Community Protection Warning Letter was handed to Wayne on the 11<sup>th</sup> November 2022 (copy attached).
- Monitoring will now be undertaken as failure to comply with the Warning Notice will necessitate service of a Community Protection Notice and possible further action in accordance with the Environmental Protection Act 1990 (Statutory Nuisance proceedings) and a potential review of the Premises Licence
- We discussed means to mitigate noise outbreak and I asked if you could provide a schedule of acoustic attenuation works that will address the problem as soon as possible.





# **Without Prejudice**

Dear Wayne and Bruce

Regrettably, the council is still in receipt of noise complaints on behalf of residents, despite best efforts to deal with the problem informally.

rollowing noise assessments carried over the last 2 weeks by a team of officers, the opinion is that activities carried out are likely to have given rise to a Statutory Noise Nuisance, which consequently necessitates action on the part of the council. Problematic noise comprises:

- o Amplified music emanating from within the premises
- o Excessive noise from patrons using the garden area
- o Amplified music in the garden area.

Given the nature of the public house and the proximity of neighbouring noise-sensitive development, whilst accepting that there are inevitable compromises to be accepted in terms of amenity as part of the 'give and take' balance, it has nonetheless been determined that the conduct of activities is unreasonable and hence a Statutory Nuisance Abatement Notice is required, pursuant to the requirements of the Environmental Protection Act 1990.

You will recall that I previously served an Abatement Notice as a result of amplified music specifically associated with the garden in 2020. There is a probability that this notice has been preached, which could result in a potential prosecution for non-compliance.

As a consequence, and given the significance of impacts that arise that now prompts formal intervention, it is considered necessary to submit a recommendation to review your Premises License and allow representatives of the parties affected to make their representations to a Licensing Committee. This Committee can then decide the most appropriate cause of action.

Further to my email of 9/6/23 which referred in part to the above.

As you may be aware, the Environmental Protection 1990 Part III (Statutory Nuisances) makes provision whereby a local authority can delay service of an Abatement Notice. These circumstances are relevant where the authority considers other steps, as it thinks appropriate, can be taken for the purpose of persuading the appropriate person responsible for the nuisance can be taken to abate the nuisance, or prohibit or restrict its occurrence or recurrence.

The relevant period for this is seven days starting with the day on which the authority was first satisfied that the nuisance existed or was likely to occur or recur. To afford you the maximum time to respond to this please do so within 7 days of receipt of this email.

With this in mind, and in an effort to resolve matters without recourse for any formal proceedings, I invite you to submit to the council a course of action of any measures, for example in the form of a noise management plan, to ensure that a statutory noise nuisance associated with amplified music emanating from within the premises does not exist, recur or occur.

I would welcome the opportunity for you to present your proposals to representatives of this authority at a meeting in the Council Offices.

As I was at the end of my tether, I contacted the environmental health department for assistance.

I have had the environmental health officers in my property on several occasions and they indicated verbally to me that this was not acceptable.

The environmental officers even walked round the nearby streets to get a view from all areas in the pub's proximity.

Due to the ongoing and unresolved issues the licensee Wayne along with his brewery manager Mr Bruce Wakelin attended my home for me to plead with them to finish the music at a reasonable time in the evening. I explained everything to both and Mr Wakelin offered me his mobile telephone number and said I could call him anytime with any issues and he would personally attend the pub, however I needed to take into consideration that he lives one hour away.

I thanked him and took the mobile number ending in \_\_\_\_\_. Unfortunately, a week later I had to call him as the noise was horrendous, it was obvious that I had woken him, he said he would call Wayne and get back to me, this did not happen. (a copy of my calls with dates and times are attached)

That night I had to endure the loud music until 00.45. I cried, I screamed, I had palpitations, I had no one to assist me. I called my partner who lives in you can imagine how angry he was and offered to come down to me as I cried uncontrollably.

The next day I called the Greene King brewery and the receptionist put me through to a gentleman named Phil Arnold (mobile ending in who advised me he was Mr Wakelin's boss he said he would investigate my claims.

Mr Arnold investigated called me back with his findings and abruptly advised me that the publican had the correct licences to allow him to have late openings and entertainment and that he could not assist me any further.

The New Pheasant as it is no called now have speakers in the garden bellowing out. Last Bank Holiday weekend was dreadful, I rang everyone to sort this, and no one is doing anything to help. I even called the police to no avail !!!!! it's not acceptable to treat residence this way.

Each time I call Wayne he always repeats I have a 1am licence and that he would close the pub doors, if he does, I can still hear the music in my property the bedroom, lounge and everywhere I cannot relax at all. Dear Emma, many thanks for your time the other day, which I very much appreciated.

Further to our discussion, can you please confirm the following:

- In relation to the complaints can you please confirm when you had complaints from parties other than and to what they related.
- Can you please provide the recordings of the noise levels your colleagues made when visiting recently (I cannot see that there is any legal reason why they cannot be provided immediately).

Wayne is able to evidence noise levels from the times complaints were received directly (or to Bruce who then passed them on) that are within the levels agreed. I think there is a general understanding and acceptance that at times has complained- where, on investigation, her complaints have been found to be unfounded. Wayne is, it is fair to say, concerned that he is being pressured into taking action without being given the opportunity to review the evidence first whilst now under a threat of review/ prosecution.

That being said, we are prepared to offer- subject to being provided with evidence that shows the levels are currently a public nuisance- the following:

- 1. A noise limiter to be fitted and set within an agreed timeframe.
- 2. We will look at installing an acoustic lobby to the rear of the premises, subject to planning and again an agreed timeframe.
- 3. We are looking into additional glazing/ potentially installing air conditioning, but this would be dependent upon understanding whether there are grants or other funds that might be available to commercial businesses in relation to upgrading their buildings- and would very much be something that would follow on from the above. We would not commit to these works or a timeframe, but are happy to look at the viability of these measures.
- 4. No speakers will be placed outside unless otherwise agreed in advance. We do want to discuss the possibility of having limited planned events outside, withing agreed guidelines, and for the benefit of the community (as many premises have- including in built up areas), but of course this will need some further thought in terms of how it might work and what would represent a reasonable compromise for all.

We are not at this stage minded to propose any restriction on the use of the garden until we understand further what evidence there is of public nuisance from customers and whether there are more appropriate mitigation measures. Wayne has installed additional fencing to try to mitigate issues and we are prepared to look at other mitigation measures to assist once we fully understand what is being alleged and therefore what would be appropriate and proportionate as a response.

Further we would propose a meeting to run through timelines and proposals to firm up an agreement. Any agreed measures can then also be worked into conditions, if relevant, on the licence which we would amend by minor variation.

We need to remind you that Wayne has put in a lot of work to improve a pub that was significantly more troublesome before he took over. We understand he has a very good working relationship with the police who we also understand form Wayne are very happy with the running of the premises. As matters stand we need to be careful that we are not throwing the baby out with the bath water. Should Wayne leave, and there is a possibility that he may decide to do so, we could end up with a worse position accordingly.

Good afternoon, Mr Warne, and thank you for your recent emails.

Firstly, I am pleased to receive what I take as positive intentions to manage noise associated with The Pheasant Inn.

I am sure your will appreciate, however, that in regard to the disclosure of evidence and information, this is of course subject to constraints given that the matter is subject to a formal investigation not least in context of statutory nuisance proceedings, and such material could potentially form part of evidential disclosure in line with normal trial proceedings. The council is subject to specific legal requirements that we cannot of course prejudice.

This said I am optimistic that a resolution can be achieved to enable The Pheasant to operate as a commercially viable entity, whilst balancing the competing needs of all concerned. As you are aware, a number of regulatory officers have been part of the council's investigations, and in essence, the findings trigger considerations to be weighed in terms of statutory nuisance, antisocial behaviour and licensing provisions, and bearing mind that there is an extant statutory nuisance already in place.

Noting what you have said, I am seeking to take every opportunity to achieve a mutually agreeable (and long-lasting) solution as soon as practicable. The matters you have indicated that can - or may be - brought into play cannot of course be made subject to disclosure of evidence on the council's part, and in-turn be held as determinants as to whether a specific remedial action will be taken forward.

The council must be in a position to accept that any intended mitigation will satisfactorily rectify problems occasioned due to noise, and I therefore counsel that independent professional advice should be sought (from a competent acoustician) who can underwrite a noise management plan/strategy, and a submission made to the council. This could then, for example, form a binding schedule to an agreed abatement notice and so provide surety to residents and the council. Given the pressing nature of this case, this is required within the next 14 days. To assist, a structured approach you may wish to progress could, but not necessarily be limited to, the elements as set out below:

- 1. A worst-case scenario for entertainment noise forms the basis for addressing noise control measures and procedures.
- 2. Use of the Licenced Premises is assessed in terms of the location used for entertainment (i.e. within the building) in order to minimise undue 'noise break-out' where possible.
- 3. Building elements are identified that can be improved in terms of sound insulation, notably glazing and doors, and practicable treatments to be effected are quantified.
- The use/installation of acoustically treated lobbies is evaluated in order to ensure control of noise is not unduly compromised by the ingress and egress of patrons.

- 5. Ensuring doors and windows otherwise remain closed during entertainment (which may also prompt attendant needs for air conditioning)
- 6. Positioning of PA systems and ensuring they are suitable in terms of design and output for the entertainment area and nature of any entertainment provided.
- 7. Use of appropriate sound-level limiting devices (accepting that it is imperative to ensure any such devices are not by-passed and are suitably set-up for the intended purpose).
- 8. Attention to the nature of entertainment that will be provided.
- 9. Administrative controls applied in respect to permitted hours of entertainment.
- 10. Identification of responsible persons to ensure events controls are maintained at all times.
- 11. Timescales concerning the above are clearly established

As far as noise associated with patrons using the garden area is concerned, this can be a challenging issue to redress, and no doubt is in part a seasonal consideration. An obvious approach is to apply an evening curfew, though design layout and the introduction of certain mitigating acoustic features may assist.

I trust this clarifies our current position and look forward to your response

Friday night was on till after midnight, the same for Saturday 12.30 also Sunday.


This is causing my stress levels and blood pressure to rise; my mental health is suffering really bad.

Hi Emma,

Here is a brief summary as to how much the pub noise and disruption to the local community has affected our lives personally. I would like to make you fully aware they are a number of house on both Wood End and Prestwood Avenue that share the same views but are either too scared to come forward or they are too elderly to be able to communicate through technology I.e phones and emails.

Both streets have residents that range from the elderly who have lived here for 40 years plus to young families who have recently move here trying to start and build a family live.

The pub brings trouble and an unwanted crowd of yobs who think it's okay to smash glasses outside your house, to argue and fight down the streets after leaving the pub, to be swearing and throwing abuse in the beer garden. The crowd it has attracted is unwanted in a family community. The pub he is trying to run belongs in a city centre where there are no close residents who are trying to live a normal quiet life. Who need sleep to be able to get up for work on a Monday.

It's not a lot to ask for, it just seems to be that this pub has been able to be managed beyond any sort of rules for over 2 & 1/2 years now and it has to stop.

They have recently gone down the route of serving food which is great! However the noise level and base is still ridiculously loud.

During the 2 & 1/2 years the level of noise and disturbance has caused a great deal of stress for me and my family. My mental health and physically health have suffered because of it. I'm in and out of hospital and require a home where I can recover in the comfort of my own home. Instead I can't sleep before 12.30 - 1.30am most night because that what time they shut off.

My kids don't have a routine due to them waking up in the night because of the music and nap times non exist because they won't sleep through the noise and have nightmares. When they have had live music it's been that loud my child screams because the drums have scared her whilst playing out. (I have attached a recording of this in another email). I am aware I'm not the only one on the street suffering with this problem. My friends house who lives closer to the pub said her kids have to sleep with her because the kids won't sleep in their own bed because of the noise which disturbs their school and affected their son last year doing his gose as he couldn't study.

I can't allow my child to play outside when there is events going on and big crowds as the level of swearing is disgusting for children to be exposed to.

We can't invite family and friends around or celebrate anything as we are embarrassed and can't even enjoy our garden or talk and hear each other.

I have lost a baby during this time and I was unable to even come home and grieve in piece instead I can home to not being able to even sleep or sit and think straight due to the continuous base that shakes the house.

The pub has caused me and my partner to argue out of frustration and stress and just genuinely being upset that we are trapped here as a family which can't move away. We can't sell due to being in a fixed mortgage.

So many people have ended up selling their properties because we all feel like we we have no way out and no one seems to be taking action against them. No other pubs are run this way. I know people who have lived her for 32 years who have up and sold up because they knew that the pub was going to carry on for a years like this because of their lease.

We thought this house was going to be our forever family home where we extended and put money into the property instead we have lost the love for it and can't wait to move.

As for the graffiti and tacky Decor they do to the near by round about which is council property, I think it makes the area look like a council estate. He has tried to bring Benidorm to wednesfield and I'm sorry to say but the cheap tacky vibe doesn't vote well with me. It affects your view when entering the round about as you can't see the other exits. I have seen a couple of near miss crashes because of this.

We have been unable to open our windows due to the noise even in the heat waves last year of 38 degrees.

I've had to pay for 2 new tyres due to the broken glass bottles with straws that on more than one occasion has found itself near my drive where I pull off which have clearly come from the pub.

The regular fights and police we hear from the pub is unbelievable. Yet the police never seem to do anything even when you see riot vans after riots vans.


My partner has nearly lost his job due to missing alarms in the morning because he's not gone to sleep till 1.30am due to the noise. They even play this loud music on a Sunday night even knowing full well people have to be up for work on a Monday. They have no thought or consideration for the local community.

The pub is a shambles and needs to be run like a normal pub. I understand it's all about money to then put for us who live near by it's our home and our lives. When they lock up they get to go home and sleep in piece and quite. They get to go to having had sleep. When they are poorly they get to relax at home and chill out to recover. They get to sunbath in their garden in peace. They get have a bath in peace. They get to have their windows open when it's hot. All these every day activities WE CAN NOT DO! They are affecting our ever day life.

We have to sleep every night with ear plugs just to be able to function. We just want to live a normal life. The fact is if they had come to wednesfield and ran the pub like every other pub landlord he would have had my support and custom. I hope he goes down the food route and sacks the live music and shit karaoke singers and start's actually listening to the local community he is upsetting instead of playing the game that he's all for the community by decorating the roundabout. For example if he's so supportive of the nhs he would be keeping people who need to go and work at the hospital awake. There are 3 nurses with is being so close to the hospital. Yet he doesn't seem to care when he's keep them awake all night and not even giving them days off to relax in peace. He is all about the money and that's it and a few banners and posters are just there as a front to make him look good to the people who spend their money in there.
